- CAMPAIGN CO-CHAIRS FRANK BASSETT & RYAN SNYDER

Frank Bassett comments:

*Thank you, Chairman, Mr. Coyle and members of the Board. It is my privilege to join Ryan again this year in bringing forth the County Worker United Way Campaign. We had a very successful campaign last year in raising over \$40,000 for the benefit of this community. Ryan has been a great partner in this effort and I thank him for joining me again this year as co-chair. I want to acknowledge a couple of key members of the campaign that are here today. Laura Geary is the chair of the countywide United Way Campaign this year and co-chairing with her is Kevin VanAllen.*

Laura Geary comments:

*Good afternoon, everyone. The individuals here are in positions of leadership and I'm sure they also feel the responsibility to make sure to help the communities. Sometimes when folks hear United Way and they give donations, it stops there. The important part that we want folks to understand is that the twenty agencies behind United Way are a conduit. The audience raised their hands for each of the twenty agencies read that they have heard of before. I think I saw many of you with your hand up every single time. So please bear in mind, that if you choose to give personally, it's not just United Way you are giving to, it's the twenty agencies that are in each of your communities that continue to make your communities vital and strong. Thank you and we appreciate all of your support.*

Frank Bassett comments continued:

*Thank you, Laura. One of the things that was brought to us last year was a request from the Undersheriff Matt Bean to get more information on each of the agencies and how much funding they have received in the past. I really want to commend Karen Rumfola. Karen is the United Way's Executive Director shared between Livingston and Wyoming County. Karen took that ask and produced a booklet within a weeks' time for distribution. If an agency did not receive a lot of money, they may not have asked for a lot. I think this will go a long way in helping folks understand the penetration of the United Way dollars that the United Way Board of Directors is able to allocate. For that reason, I encourage everyone to consider the community fund for your donations. I also want to recognize Barry Haywood. Barry has served as president of the United Way Board for his third term now and has provided great leadership. As part of the leadership, following a strategic planning process thereby looking at the function of the board, the allocation process and the designation of monies to agencies. Really looking at how deeply they penetrate the communities of Livingston County. This year we are making a special ask. In recognizing the size of the County workforce, there are over 1,100 County employees that serve this community through direct employment with the County; we are asking the 400 County employees donate this year. Last year we had 224 employees that chose to donate to the campaign. Even so little as \$1.00 a week would enable us to help so many more in our community. Help us help them.*

Ryan Snyder comments:

*I am pleased to join Frank again this year. I have really enjoyed my involvement with United Way the past three years. We rely heavily on our department coordinators and our campaign coordinators. They do a wonderful job helping to continue to beat the drum at the department head level raising the donations that contribute to those 224 donors that Frank mentioned. In addition, we have generated some new marketing materials to help in that effort this year. One such item is a Q&A pamphlet to help be more proactive in dispelling some myths that exist about United Way dollars. We are continuing to be aggressive with the chairman pushing us to be our best and have set the goal at \$38,000 again this year. Again, because this same goal was exceeded last year. The County campaign really sets the trend for the rest of the overall County worker campaign. I think that we have an aggressive goal but if we all work together we can beat it again this year.*

Frank Bassett recognized Stuart Atkins. Stuart serves with two hats in the Legal Aid Society. In the one program we have a testimonial from today, is the Youth Advocacy Program and Paul Kennedy is here to speak.

Paul Kennedy comments:

*Good afternoon. I am here on behalf of Stuart and Youth Advocacy. I had situation with my son this last school year, 15/16, in which he was reprimanded from school for approximately 1 year. There was a long hard felt battle and the help of Stuart and the Agency, not only myself, but some other people in our school district that were in the same situation as well. Without the help from Youth Advocacy, my son, along with some other students would not have been back to school for approximately one year. With the pain that our family and some of the other families dealt with at that time, without Stuart's help and the agency, it would have been a very long year. Thank you for all of your help and giving to that program. It is very, very well worth it.*

Chairman Gott thanked Ryan and Frank for their leadership once again this year. He is confident that the workforce of Livingston County will step up and meet that 400 person goal, as well as, crush our goal financially again this year. Anything we can do as department heads as we head back to our individual departments to work with the coordinators and employees would be fantastic. Ryan and Frank are always available if there are any questions, concerns or comments.

RESOLVED that compensation as described herein will be provided to Emergency Medical Technicians:

- All part-time, permanent Emergency Medical Technicians who have worked at least 750 hours in the prior pay year without a break in service shall receive a longevity increment of an additional \$0.32 per hour for all hours worked in the year following the first pay year in which they meet this standard, and an additional \$0.22 per hour for all hours worked in any subsequent year in which they meet this standard during the prior pay year, with a cumulative maximum total of \$2.08 per hour in longevity increments.
- An employee who is receiving a longevity increment(s) who then has a break in service shall lose all longevity increment(s) and shall be treated as a new employee if he/she returns following the break in service. An employee who is receiving a longevity increment(s) who then has a pay year with less than 750 hours of work shall not earn an additional longevity increment for that year but shall retain his/her previously earned longevity increment(s) (unless a break in service occurs).
- Longevity increments for 2016 shall become effective March 6, 2016.
- Longevity increments for 2017 and subsequent years shall become effective at the beginning of the first full pay period following the first of the calendar year.
