1. FORECLOSURE UPDATE-There is now 34 parcels for the auction. One parcel was removed because the property owner filed an answer. It is an additional fee of \$2,500 for Phillips Lytle to continue and the County Attorney feels that we should proceed. We would need to do an additional auction or sealed bid process in order to sell this parcel before the end of the year. Mr. Pangrazio explained the history of the property and the current business leasing the property. This business is looking at property in Monroe County if unable to purchase this parcel. It is unsure whether the judge will allow the taxes to still be paid or not.

Motion: Mr. Gott moved and Mr. Mahus seconded to authorize the County Treasurer to move forward with this matter and have Phillips Lytle proceed with striking an answer...Carried.

Chairman Gott explained that 48 Perine Street in Dansville has been condemned and the Village of Dansville is interested in purchasing this parcel. The County has done this in the past. There was discussion on the requirements that restrict the municipality from reselling the property. The County Attorney needs to discuss any restrictions with the Village. The Committee agreed that the Village could pay the taxes owed to transfer ownership to the Village.
