INTRODUCTION OF LOCAL LAW

LOCAL LAW NO. A OF THE YEAR 2017 A LOCAL LAW ADOPTING THE LIVINGSTON COUNTY GUEST ROOM OCCUPANCY TAX LAW AND RESCINDING ALL PREVIOUS HOTEL AND MOTEL OCCUPANCY TAX LOCAL LAWS AND AMENDMENTS IN LIVINGSTON COUNTY

Chairman Gott asked the County Attorney to comment on the Local Law A-2017.

County Attorney David Morris explained that this local law provides a couple changes to the existing hotel motel occupancy tax law. The first change modifies the definition of what constitutes an establishment subject to the tax. This change was recommended by the Chamber of Commerce. It makes it clear that temporary housing for instance, individuals that may rent out their residence or a room in their residence for a week or two at a time are subject to the tax and have to collect the tax. The second change has to do with the definition of the rent that is actually subject to the tax. The new definition indicates that any money received no matter how it is designated, is subject to the tax. The reason for that change was that we are trying to get certain companies like Air BNB, Expedia and those type to start collecting the Hotel Motel Tax when those rooms are listed through those entities and they have indicated to us that in order for them to do that, they really have to have the rent as a single rental figure that is subject to the tax. It makes it more efficient for them to be able to collect in the end.

Chairman Gott explained that the introduction for resolutions will be changing. The County Administrator and County Attorney have discussed the matter and we are no longer going to have the Clerk of the Board read the dated at portion of each resolution. She will be reading the titles only for the Committee Chairs to make the motions.

- Section 10. Effective as hereinafter provided, the annual salary of the Personnel Officer shall be increased by \$1,950.00.
- Section 11. Effective as hereinafter provided, the annual salary of the Public Defender shall be increased by \$1,975.00.
- Section 12. Effective as hereinafter provided, the annual salary of the Public Health Director shall be increased by \$1,925.00
- Section 13. Effective as hereinafter provided, the annual salary of the Sheriff shall be increased by \$3,350.00.
- Section 14. All salaries set forth herein shall be effective as of January 1, 2017.
- Section 15. This Local Law shall take effect on the date of filing in the Office of the Secretary of State of the State of New York.
- Section 16. This Local Law is subject to permissive referendum.
