PUBLIC HEARING**LOCAL LAW NO. H - 2015 - COUNTY OF LIVINGSTON PROVIDING SALARIES FOR CERTAIN COUNTY OFFICERS FOR THE YEAR 2016**

Chairman Gott asked the County Attorney to comment on the local law.

County Attorney David Morris explained that the local law provides legal authority to give salary increases to elected and appointed officials during their terms of office and is applied specifically to the officials set forth in the law. Public Officers who are appointed or elected for a definite term cannot have their salaries increased during their term office except by local law. We do this on an annual basis.

Chairman Gott declared the Public Hearing open and stated anyone interested in speaking to please come forward and sign in at the podium. No one wished to speak. The Chairman asked if any Supervisor wished to comment. The Chairman announced that the public hearing would remain open until the end of the meeting.

INTRODUCTION OF LOCAL LAW**LOCAL LAW A-2016 AUTHORIZING THE COUNTY OF LIVINGSTON TO SELL .546 ACRES ON BANK STREET IN THE VILLAGE OF DANSVILLE BY PRIVATE SALES**

Be it enacted by the Board of Supervisors of the County of Livingston as follows:

- Section 1: The Board of Supervisors of Livingston County intend by this local law to supersede the provisions of County Law § 215 (5) and § 215 (6), which limits sales of County real property to the highest responsible bidder after public advertisement. The County of Livingston acquired 7 Bank Street, Dansville, New York (former Wilcox Press property) by tax foreclosure and had the property remediated with the assistance of a New York State grant. Three adjoining landowners and the Village of Dansville have requested small parcels from the County to clear up boundary and encroachment issues and to provide additional parking for the Village Park. The County of Livingston elects to supersede the provisions of County Law § 215 (5) and § 215 (6) and allow the private sales of these parcels.
- Section 2: The County of Livingston, by resolution adopted January 13, 2016, declared 4 small parcels (.546) located within the 7 Bank Street parcel in the Village of Dansville to be surplus property.
- Section 3: The County of Livingston is hereby authorized to sell said parcels to the following persons at the price set forth herein:
- a. Tricia Anne Guerin, .359 acres, \$3,493.93;

- b. Virginia C. VanWinkle, .074 acres, \$743.13;
- c. James and Susan Jackson, .046 acres, \$350.00;
- d. The Village of Dansville, .077 acres, \$1,000.00.

Section 4: This local law is subject to a permissive referendum.

Section 5: This local law shall take effect on the date of filing with the Secretary of State of New York.

County Attorney David Morris explained that under County Law, County real property can only be sold to the highest responsible bidder after public advertisement. This local law will supersede that provision of County Law and authorize the sale of four parcels in the Wilcox Press subdivision in Dansville to four owners at private sale. These are small parcels within the subdivision that adjoin these landowners property. It takes care of some encroachments there. There is also a conveyance to the Village of Dansville to be used for additional parking.

2. County Administrator Updates:

-With this local law introduced today, the Wilcox Press project is finally coming to completion. This was one of the first projects on his desk when he started in 2008 with the length of the State environmental restoration project and everything else we had to do with this effort. 3. We are working on the federal/state legislative agenda that we develop every year to be presented at the next Ways and Means Committee meeting. Begin thinking about that as we look to frame our "wish list" of what we want to see out of Albany and Washington.

4. There were 4,881 people accommodated at our Al Lorenz Park through our reservation system, up 15% from last year.
