Mrs. Ellis thanked Chairman Gott and stated that it is a great privilege that the Planning Department can join with the Board of Supervisors in presenting the 2016 Earth Day Award and turned the podium over to past EMC President Ray Case.

Ray Case Comments:**The EMC:**

In 1979, the Board of Supervisors created the Livingston County Environmental Management Council (EMC). Its charge is to work cooperatively with the Board of Supervisors, local municipalities, and citizens of the County on the protection, preservation, development and use of the County's natural resources. The Council currently consists of 13 volunteers representing three broad constituencies: agriculture, general citizens and industry-commerce.

If those EMC members present would please stand to be recognized.

The EMC has completed their 2015 Annual Report, and it is on the Board of Supervisors' desks for review. Highlights include sponsoring/co-sponsoring six public educational workshops, and awarding the 17th Annual Earth Day Award.

Today marks the 46th Anniversary of Earth Day. Earth Day, celebrated annually on April 22, is a global event aimed at inspiring awareness and protection of and appreciation for the Earth's environment. On the first Earth Day in 1970, an estimated 22 million Americans celebrated clean air, land, and water. Today, more than 1 billion people worldwide participate in Earth Day activities, making it one of the largest civic observances in the world.

In support of Earth Day, the EMC established the annual Livingston County EMC Earth Day Award. The award is intended to recognize individuals, businesses, agencies, or organizations for outstanding achievements in preserving or improving the Livingston County environment or educating others about Livingston County's environment. The EMC received several nominations this year for its 18th annual Earth Day Award and would like to take the opportunity to recognize those that were nominated for their positive efforts:

WHEREAS, the County has held a public hearing on April 13, 2016 to obtain citizens’ views regarding the CDBG program as administered by OCR and the Project, now therefore be it

- LIVINGSTON COUNTY VOLUNTEER RECOGNITION CEREMONY

Chairman Eric Gott

We do have a very special event today. It's an opportunity for Livingston County to recognize its' volunteers. At this point, I'm going to turn it over to Ian Coyle, our County Administrator, and we will begin the program. Thank you all for being here.

County Administrator Ian Coyle

Before I begin, I want to say thank you the people that had the initiative and intuition to start this program. Heather Grant, Planning Director Angela Ellis and her team. They are the ones that really spearheaded this effort to recognize our volunteers. We do annually recognize our seniors, and that is next week; our teenagers, and that is tonight; and we recognize our employees in a formal recognition ceremony, and that is done in June. There was a thought, "What about our volunteers?" We should recognize our volunteers for all of the countless efforts and hours that they put in each and every day. To further emphasize and to substantiate the fact that "I" was not the one coordinating this event today, I saw the display outside with all the stars and the balloons, cupcakes and food out there, there were these footer looking things supporting the ceiling. I thought we had building foundation issues before they hung all the stars on the strings. I want to thank everyone for putting this together. If you look around, all these people are volunteers for the County. They are in support boards'; they are volunteering for agencies and advancing the cause, without pay and without compensation. And as great as the turnout is here in this room and spilling out into the hallway, it is about one-third of our total volunteer base that was able to make it today. It is fantastic that we got 100+ people that were able to be recognized and show up today. We really appreciate that. We have a total of 330 volunteers that help support county operations spread across our 32 departments. That is an excellent statistic. We have representatives from all 17 towns and all 9 villages. People that volunteer each and every day. I do the budget for the County. If it is a bad budget, next year someone else does it. I'm a numbers guy, so I tried to quantify what this represents and it is difficult because we have some people that have almost a full-time job volunteering for us in some capacity and we have other people that volunteer sporadically. It's literally in the hundreds of thousands of dollars in man and woman hours that are worked by the volunteers of this county. It is a tremendous savings to us, it is a tremendous benefit to us, and it is a tremendous value to us in county government that we are able to get that. Just to put that in numbers, if everybody is doing just a couple of hours every week, and there are some that do many more and a few that do less, but averaging out, it is about 34,000 hours committed on an annual basis by our volunteers. You throw a wage in there and it is in the range of \$300,000-\$500,000 of labor right off the bat, and probably on the low end. We would have to raise taxes tremendously if we had to fund those staffing operations, so we really thank you for that. We are going to have a ceremony afterwards, but I would like to end with this, taken directly from the submissions of the volunteers, what I have compiled as the Top 10 Reasons Why We Volunteer....

#10 When you stay home you get too many telemarketing calls

#9 Your family could use a break from you

#8 You, yourself, might need help some day

#7 It's hard to win the game of solitaire

#6 Soap Operas all sound alike, except the Spanish ones which are a little different

For that, we thank you. We thank you for your dedication and we thank you for your service. You are deemed the ALL STARS OF COUNTY GOVERNMENT! I would like to give you all a round of applause.

The Board of Supervisors, County Administration, Department Heads and County employees presented all of the volunteers with a standing ovation.

At this point we are going to start the actual program and I am going to turn it over to Michele Rees.

Clerk of the Board Michele Rees

After receiving your certificate, you will exit down the right side of the room to return to your seats.

County Planning-Director Angela Ellis

County Planning Board-*It is my pleasure to introduce the volunteers for the County Planning Board, Agricultural & Farmland Protection Board, Environmental Management Council, and Conesus Lake Watershed Council. These volunteers serve as the foundation to success for Planning Department programs and projects.*

I will start with the County Planning Board-The Livingston County Planning Board plays a key advisory role in development in Livingston County. NYS General Municipal Law requires local boards to refer certain development applications and proposed zoning changes to the county Planning Board for review. The purpose of the review is to encourage local decision-makers to consider the inter-community and countywide impacts of local land use changes and add a regional perspective to local land use decisions.

The County Planning Board is comprised of 23 members representing almost every Town and Village in Livingston County plus alternate at-large members.

The Board has 14 members (over half the membership) with over 10 years of service. The total years of service for the current membership is 284 years.

Agricultural & Farmland Protection Board-*The Livingston County Agricultural & Farmland Protection Board (AFPB) was created in 1993, by the Board of Supervisors. The Ag Board acts to help protect farmland and farming operations. Primary activities include*

- *Overseeing activities in support of the County's Agricultural District Program;*
- *Working collaboratively with the Genesee Valley Conservancy and partners on the Livingston County Purchase of Development Rights Program.*
- *Reviewing and providing recommendation on proposed municipal agricultural and farmland protection plans.*
- *Overseeing implementation activities for the County's Agricultural and Farmland Protection Plan, which was approved in 2006.*
- *Reviewing proposed water and sewer improvements and making recommendations on possible impacts to farming operations.*

The Board is comprised of 10 members. 6 members have over 10 years of service. The total years of service for the current membership is 145 years.

*2 members have between 15 and 20 years of service – Robert Sturm and Chris Cicero
Supervisor David LeFeber of Avon stepped down last year with 13 years.*

Environmental Management Council-*I probably don't need to do much of an introduction for the EMC since we just heard presentation on the Earth Day Award....As Past EMC Chairman Ray Case indicated, the Environmental Management Council was formed in 1979 as a County-appointed body that advises the Livingston County Board of Supervisors on matters affecting the environment. In addition to the Earth Day Award, the EMC also:*

- *Sponsors environmental education programs and training workshops for municipal planning and zoning officials.*

- *Acts as a resource for Livingston County by participating on county and regional committees involving matters of the environment.*
- *Is responsible for maintaining the Livingston County Natural Resources Inventory (NRI) – a listing of important natural and historical assets located in the county.*

The EMC membership is currently comprised of 13 representatives. 5 members have more than 10 years of service. The total years of service for the current membership is over 156 years.

Conesus Lake Watershed Council-Last but not least.....*The Livingston County Conesus Lake Watershed Council (CLWC) was established in 2003 to oversee the implementation of the Conesus Lake Watershed Management Plan (2003).*

The successful work of the Conesus Lake Watershed Council relies heavily on citizen volunteer involvement on the Council and on the various committees, including the Technical Committee, Agricultural Committee, Public Education Committee, and Invasive Species Subcommittee. Our agency relies on volunteers. We could not exist without them. Not all, but many are elders themselves. We have an advisory council that must be made up of at least 50% seniors representing the areas that we serve. This council meets 7-8 times per year and I refer to their functions as "The Triple A", Advisors, Advocates and Ambassadors. They advise us on our annual plan, resource allocation and needs. They advocate with public officials on behalf of older adults and caregivers. Recently they were all making calls and writing letters to make sure that the Older Americans Act was reauthorized and that the state put ample funding into the Community Services for the Elderly Program. They act as ambassadors to the seniors' clubs, taking information from the advisory council back and bringing information about needs and concerns to the Council and they also help with events. If you come to York Central School on May 7, you will see them at Seniorama. Foster Grandparents are all volunteers. These incredible individuals volunteer 15-20 hours per week, week in and week out to assist children in classrooms to be successful. These people have been volunteering from less than one year to over eleven years. In total, the current Livingston County Foster Grandparent volunteers have volunteered for 48,067 hours. Our senior nutrition program utilizes the greatest number of volunteers on an annual basis. The program relies on volunteers to deliver meals within the Villages of Avon and Dansville, to assist at the three congregate sites in Avon, Mt. Morris and Dansville and to help with foodlink distribution. These volunteers not only make sure meals are distributed, they also provided countless smiles, caring and a sense of connection.
