1. TOM MATTHEWS – SUNY GENESEO ASSOCIATE DEAN OF LEADERSHIP AND SERVICE

- LIVINGSTON CARES ANNUAL REPORT

Dr. Matthew's comments:

Thank you for the opportunity to come back and share with you since we last presented two years ago. On each of your desks is a special edition of the annual report commemorating 10 years of work that started in January of 2006 when we took our first trip to Biloxi, Mississippi. You may recall that in August it was the first week of school in 2005 when Hurricane Katrina hit the gulf coast and was the largest natural disaster in the history of the country. The devastation was unbelievable. In early September, the Board of Supervisors passed a resolution offering support to the citizens of Harrison County, Mississippi. I want to call your attention to page 46 and 47 of the report you will see the resolution they just passed and presented to us, 10 years later this past January, at a Harrison County Board of Supervisor meeting thanking Livingston County, Livingston CARES and the citizens of our area for all of the work we have been doing in Mississippi. There have been over 62 service trips, most of which are one week long work weeks that students, faculty, staff and key community people have done since January 2006 helping others. In Mississippi we are primarily reconstructing homes and after Hurricane Sandy, Staten Island, Long Island and this year, we are doing work in Brooklyn. It is still very apparent that it was Hurricane Sandy damage that occurred. The value of the work that has been done over these 10 years plus Calculating both fees that students and participants in our trips have taken and service hours is \$1.6M contributed by our people in Livingston County and at the College over these last 10 years. This is a lot of those good things that people do and service and I will ask you to help. Eric, I appreciate you attending our annual rewards dinner in March. We called it Livingston Cares for a reason. We didn't want it just to be the College. We could have called it Geneseo Cares or SUNY Geneseo Cares, but we deliberately used the name Livingston County so that it would have broader citizen involvement. We are always looking for volunteers if you know of anyone in your towns or villages interested. We are going to continue the work. We have two groups leaving on Sunday after graduation, one going to Biloxi and one to Brooklyn to do a week-long service. Thank you for your involvement and support and particularly Brenda Donohue is now serving and representing you on our Livingston Cares Board of Directors. She really helps make a wicked gumbo for our Gumbo to Go fundraiser. I want to introduce Samantha Hebel, who is our new Coordinator of Volunteer Service at the College. A few years back people said "while you are doing all this work in Biloxi, how about in Livingston County?" We have created a program called Geneseo Goes to Town in which we send volunteers out to each town and village in the County. Sam is

primarily responsible for that program. Next year it will be on April 1st. We hope that Sam can call on some of you as Town Supervisors to help identify groups within your communities that we can send students out for a Saturday day of service. We like to keep those connections between the College and the community. We certainly welcome any van drivers for trips. One thing that I have learned over the years is that students often talk about having a great experience with all the conversations and working together with another generation. Please review this report and I am happy to answer any questions if you want to give me a call about what we are doing. We are going to continue this work. It is now a part of the culture at Geneseo and I hope it continues to be part of what we do in Livingston County. This makes a significant difference to the students. I read and hear all the time from alumni, on how much this matters in their careers and work ethics.

Mrs. Donohue comments:

This is my absolute favorite committee to be a part of in representing the Board of Supervisors. The commitment of time dedicated by the students and faculty is absolutely amazing. They pay their own way down there and help pay for food and sometimes help pay for materials and they give up a week of their time, but speak of it glowingly when they come back. They are wonderful citizens.

Chairman Gott thanked Dr. Matthews and stated that the Supervisors will look forward to hearing from Samantha.

2. RYAN SNYDER – DIRECTOR OF WORKFORCE DEVELOPMENT & YOUTH BUREAU

• SUMMER YOUTH EMPLOYMENT

Ryan Snyder comments:

Good afternoon and thank you for this opportunity to speak to you about the Livingston County summer youth employment program. I have been given assurance that if I keep my remarks brief and avoid making fun of the County Administrator, as some others have done, then I will receive high marks.

The intention of my presentation is to inform you of the opportunities that exist for youth in your Towns to benefit from summer employment, and to highlight some of the enhancements we have made to the program over the last three years. These changes were implemented for the purpose of improving our program outcomes as well as the experiences of both program participants and worksite sponsors.

First, some basic background on the program - Funding is provided by the NYS Office of Temporary and Disability Assistance for the purpose of providing summer work experience for economically disadvantaged youth. Eligible participants are between the ages of 14 and 20 and are either members of a family receiving public assistance or living under 200% of the federal poverty guidelines.

Applications are collected each spring with referrals primarily originating from school districts, county agencies and youth service programs. This year 92 applications were received and 60 youth attended their scheduled interviews. The highest concentration of applicants was from Mt. Morris at 27% followed by 16% in Dansville and 13% from both Geneseo and Nunda. Upon selection, youth are hired as county employees and receive minimum wage employment for a period of up to five weeks.

The first area we targeted for improvement was the retention of youth during the program. Youth were increasingly ending their employment before completion, resulting in declining retention rates on the job. The trend is highlighted in the table on the screen. At the same time, the frequency of staff interventions at our worksites was increasing. The youth we were serving were exhibiting more intensive needs and we needed to respond to correct their behaviors. The first change we made was the implementation of an unpaid weeklong work readiness training program held at GCC Dansville. The program replaced a one day of paid orientation that preceded it. The full week enabled us to determine the commitment of the youth by monitoring their attendance, participation and behavior for an extended period of time, before placing them at a worksite. The new structure also provides our staff a better opportunity to identify and alleviate the individual barriers which could impact their ability to be successful. Youth spent six hours each day in a class room learning about subjects like work place expectations, conflict management and effective communication and receive employment services to prepare for their next job. This new model coupled with a new mandatory attendance policy, shifted the youths attitude from that of an entitlement to a job to a feeling of gratitude for the opportunity. During the week, one of the skills we emphasize is effective communication during job interviews. We teach many techniques that have been tested over time and proven to be successful. Following successful completion of the pre-

week, we have a better understanding of the abilities and interests of the youth so that they can be placed in a more meaningful work experience.

We are constantly developing new sites in both public and private organizations that can meet the geographic limitations of the applicants. If you have any suggestions for prospective worksites in your town, please refer them to me. Longstanding worksites including sites include Morgan Estates, Campus Auxiliary Services, Grizzly's, Army Corp of Engineers, Town and Village Recreation programs, school districts and county departments. We also operate a staff led work crew that performs community service projects around the county, while alleviating the transportation barriers for some of our participants.

The second substantial changes we made to the program were the implementation of a career exploration program for younger youth. Youth under 16 experienced the lowest job retention rates and a higher incidence of disciplinary incidents than their older classmates. This can be the result of their immaturity or inexperience. NYS Labor laws also prevent this group from performing many of the tasks commonly requested by our worksites. To overcome these challenges, we formed a new partnership with the Business Education Alliance and Genesee Valley Education Partnership to coordinate and host a career exploration program. Participants selected for this path receive an hourly stipend for their participation which consists of class room instruction, hands on skill development and field trips of in-demand industries. Upon successful completion of the experience, participants are far better prepared for a direct worksite the following summer.

Opportunities for the program are available to all income eligible youth in Livingston County, despite any physical or intellectual disabilities they may possess. Currently, 44% of the applicants to the program have a documented disability requiring school interventions. Through a new partnership with the Arc this summer, those with the most significant disabilities will be placed in a more supportive program with additional resources provided, including job coaching and free transportation. This new effort will also help to connect these participants with additional services that can be available to them throughout the year. Other disadvantaged populations served in the program include youth with criminal backgrounds, youth that are pregnant or parenting, high school dropouts and youth receiving mental health or substance abuse counseling.

More intensive pre-screening, clearer worksite expectations and more appropriate placements have resulted in the improvement in outcomes that we were seeking. Job retention increased more than 25% in the first year and has remained above 90% ever since. Worksite attendance is nearly perfect and disciplinary reports are almost non-existent. Youth are frequently offered paid employment at the conclusion of the program and most participants don't return the following year because they can secure their own employment.

I would like to leave you with a quote from one of last summers' participants about what she learned in the program- "I learned to work well with others and put our differences aside to achieve the goal".

These are the lessons that we are teaching each day and I am pleased to be joined today by two of my co-workers, Mary Guldenschuh and Catherine Hilfiker, who were instrumental in the redesign of our program and the delivery of services on a daily basis. Thank you both for the difference you make each day in the lives of youth in our County.

I would be happy to answer any questions you may have about the program.

RESOLUTION NO. 2016-155 A RESOLUTION CALLING ON THE STATE OF NEW YORK TO FULLY REIMBURSE COUNTIES FOR MANDATED COUNTY COSTS FOR INDIGENT DEFENSE SERVICES-PUBLIC DEFENDER

WHEREAS, on April 4, 2016 the Office of Indigent Legal Services issued new “Criteria and Procedures for Determining Assigned Counsel Eligibility”, which are scheduled to become effective on October 3, 2016; and

WHEREAS, this new criteria took the existing program, which based eligibility for assignment of counsel at 125% of the Federal poverty line and increased it to 250% of the Federal poverty line, thereby vastly increasing the number of eligible individuals; and

WHEREAS, this new criteria eliminates household assets and spousal income in determining eligibility and uses net income not gross income for eligibility; and

WHEREAS, the new eligibility criteria will increase caseloads of most county providers and impose additional administrative requirements and costs on county providers; and

WHEREAS, the higher caseloads and increased administrative responsibilities will have significant, adverse effects on county providers unless there is additional funding appropriated to support providers in complying with the new eligibility criteria; and

WHEREAS, the new eligibility criteria have been issued by New York State without any additional State funding to support providers in their implementation; the vast majority of counties will not be able to provide the additional resources necessary to implement the eligibility criteria while continuing to provide quality representation to clients and while being constrained by the state-imposed property tax cap which leaves little room to address increased services without state assistance; now therefore be it

RESOLVED, that the County of Livingston calls on the State of New York to immediately pass legislation and appropriate additional funding to support counties in complying with the new eligibility criteria, and not pass this unfunded mandate on to local taxpayers and directs that the Clerk of the Livingston County Board of Supervisors forward copies of this resolution to Governor Andrew M. Cuomo, New York State Senator Catharine M. Young, New York State Senator Patrick M. Gallivan, Assemblyman Bill Nojay and the New York State Association of Counties (NYSAC).
