# REGULAR BOARD MEETING WEDNESDAY, JUNE 28, 2017 1:30 P.M.

### **ROLL CALL**

The roll was called showing all members present except Mr. Schuster (Sparta and Mrs. Babbitt Henry (Springwater).

### **PLEDGE OF ALLEGIANCE**

The County Administrator introduced Nicholas Finocchario.

Nicholas Finocchario was born in South Lima, New York and graduated from Livonia High School in 1996. He enlisted in the United States Army in July of 1996 and served until he was honorably discharged as an E-4 Specialist in 1999

Nicholas completed basic training in Ft. Jackson, South Carolina and attended his Advanced Individual Training (AIT) at Ft. Knox, Kentucky. After graduating from AIT school he was stationed at Ft. Hood, Texas where he was assigned to the 2nd Battalion 7<sup>th</sup> Cavalry of the 1<sup>st</sup> Cavalry Division. During this time span he had deployed to Camp Doha Kuwait for Operation Intrinsic Action.

After his active duty assignment, Nicholas worked for Caterpillar in Henrietta, New York.

In 2001 he started working for CP Ward in Scottsville, New York. In the wake of the September 11, 2001 attacks he was recalled from inactive duty reserves to the active reserves where he served from March of 2002 to June of 2004. During this time, he was stationed to the 98 Division in Rochester, New York. He served as a 63 Tango – Bradly Tank Mechanic and had specialized training as an H8 for recovery operations.

Nicholas Finocchario followed family tradition, with a great-grandfather serving in World War II, and his grandfather serving in Korea. For his military service, Nicholas was awarded the National Defense Service Medal, Army Achievement Medal, and the Armed Forces Expeditionary Medal.

In 2014 Nicholas started working for the Livingston County Highway Department as a Mechanic. He currently resides in South Lima with his wife Jennifer and their two children and a foster child they are hoping to adopt soon.

Nicholas Finocchario, led the Pledge of Allegiance.

The County Administrator and Chairman Gott, on behalf of the Livingston County Board of Supervisors, presented a Certificate of Appreciation to Nicholas Finocchario. The audience presented a standing ovation.

### PUBLIC HEARINGS

1. COMMUNITY DEVELOPMENT BLOCK GRANT APPLICATION TO THE NEW YORK STATE OFFICE OF COMMUNITY RENEWAL

Chairman Gott asked Economic Developer Bill Bacon to comment on this public hearing.

Mr. Bacon explained that the purpose of today's hearing is to provide information to the public regarding the Community Development Block Grant/CDBD Microenterprise Program and to consider comment on a proposed application being requested for submittal by Livingston County. An application in the amount of \$200,000 is being proposed to the New York State Office of Community Renewal/OCR to provide grants in conjunction with capacity building and entrepreneurial assistance to support and foster development of as lease 5 microbusinesses to be located in Livingston County with the anticipated creation of at least10 new jobs. Pending the successful outcome of the grant application, it is proposed that the County enter into a sub-recipient agreement with Livingston County Development Corporation to administer the funding. Entrepreneurial training will be a prerequisite of grant funding and technical assistance will continue to be offered to businesses on an as needed basis.

2. LOCAL LAW C-2017 LOCAL LAW REPEALING THE WIRELESS COMMUNICATIONS SURCHARGE AUTHORIZED BY ARTICLE SIX OF THE COUNTY LAW OF THE STATE OF NEW YORK; AND IMPOSING THE WIRELESS COMMUNICATIONS SURCHARGES PURSUANT TO THE AUTHORITY OF TAX LAW § 186-G

Chairman Gott asked County Attorney Shannon Hillier to comment on the local law.

The County Attorney explained that this particular local law allows the County to continue to collect a 30¢ surcharge on all wireless devices on a recurring monthly bill. In addition to that, it adds on the ability to collect the said surcharge on prepaid wireless devices, for example, trac phones.

Chairman Gott declared both public hearings opened and stated that anyone interested in speaking should please come forward and sign in at the podium. No one wished to speak. The Chairman asked if any Supervisor wished to comment. The Chairman announced that the public hearings would remain open until the end of the meeting.

WHEREAS, the County has held a public hearing on June 28, 2017 to obtain citizens' views regarding the CDBG program as administered by OCR, now therefore, be it

RESOLVED, that the Chairman is hereby authorized to submit a grant application on behalf of the County in an amount not to exceed \$200,000 to the OCR to support a Microenterprise Program, and be it further

RESOLVED, that the Chairman is hereby authorized to execute a grant agreement between the County and the OCR and all related documents associated with the OCR grant, including entering into a grant agreement with the LCDC for the implementation of the Project and administration of the OCR grant, all such documents to be subject to review and approval by the County Attorney, and be it further

RESOLVED, that the Chairman is hereby designated as the Certifying Officer responsible for all activities associated with the federal environmental review process to be completed in conjunction with the Microenterprise Program.

# MOTION TO MOVE LOCAL LAW NO. C - 2017

Local Law Repealing The Wireless Communications Surcharge Authorized By Article Six Of The County Law Of The State Of New York; And Imposing The Wireless Communications Surcharges Pursuant To The Authority Of Tax Law § 186-G

Mr. Yendell moved and Mr. Wadsworth seconded to move the proposed local law to the table for a vote. Carried.

### **VOTE ON LOCAL LAW**

LOCAL LAW NO. C-2017 LOCAL LAW REPEALING THE WIRELESS COMMUNICATIONS SURCHARGE AUTHORIZED BY ARTICLE SIX OF THE COUNTY LAW OF THE STATE OF NEW YORK; AND IMPOSING THE WIRELESS COMMUNICATIONS SURCHARGES PURSUANT TO THE AUTHORITY OF TAX LAW § 186-G.

Be it enacted by the Board of Supervisors of the County of Livingston, as follows:

**Section 1.** Imposing a Surcharge Upon Wireless Communication Devices Local Law No. 6, of 2002, is hereby REPEALED. **Section 2.** Imposition of wireless communications surcharges.

(a) Pursuant to the authority of Tax Law § 186-g, there are hereby imposed and there shall be paid surcharges within the territorial limits of the County of Livingston on: (i) wireless communications service provided to a wireless communications customer with a place of primary use within such county, at the rate of thirty cents per month on each wireless communications device in service during any part of the month; and (ii) the retail sale of prepaid wireless communications service sold within such county, at the rate of thirty cents per retail sale, whether or not any tangible personal property is sold therewith.

(b) Wireless communications service suppliers shall begin to add such surcharge to the billings of its customers and prepaid

wireless communications sellers shall begin to collect such surcharge from its customers commencing December 1, 2017. (c) Each wireless communications service supplier and prepaid wireless communications seller is entitled to retain, as an administrative fee, an amount equal to three percent of its collections of the surcharges imposed by this local law, provided that the supplier or seller files any required return and remits the surcharges due to the New York State Commissioner of Taxation and Finance on or before its due date.

- **Section 3.** Administration of surcharges. The surcharges imposed by this local law shall be administered and collected by the New York State Commissioner of Taxation and Finance as provided in paragraph (8) of Tax Law § 186-g, and in a like manner as the taxes imposed by Articles Twenty-eight and Twenty-nine of the Tax Law.
- **Section 4.** Applicability of State law to surcharges imposed by this local law. All the provisions of Tax Law § 186-g shall apply to the surcharges imposed by this local law with the same force and effect as if those provisions had been set forth in full in this local law, except to the extent that any of those provisions is either inconsistent with or not relevant to the surcharges imposed by this local law.
- Section 5. Net collections received by this county from the surcharges imposed by this local law shall be expended only upon authorization of the Board of Supervisors of the County of Livingston and only for payment of system costs, eligible wireless 911 service costs, or other costs associated with the administration, design, installation, construction, operation, or maintenance of public safety communications networks or a system to provide enhanced wireless 911 service serving such county, as provided in paragraph (9) of Tax Law § 186-g, including, but not limited to, hardware, software, consultants, financing and other acquisition costs. The county shall separately account for and keep adequate books and records of the amount and object or purpose of all expenditures of all such monies. If, at the end of any fiscal year, the total amount of all such monies exceeds the amount necessary for payment of the above mentioned costs in such fiscal year, such excess shall be reserved and carried over for the payment of those costs in the following fiscal year.

**Section 6.** This local law shall take effect December 1, 2017.

- 2. EMPLOYEE RECOGNITION CEREMONY HONORING EMPLOYEES WITH 10 AND 25 YEARS OF FULL-TIME SERVICE

### Chairman Eric Gott

I would like to welcome our fellow employees, department heads, family, friends and relatives to our annual Employee Recognition event. This is certainly an exciting day for the Board of Supervisors because it is an opportunity to recognize our best asset and that is our people. The services that are provided to Livingston County folks each and every day could not happen and would not happen without the great employees and department heads of this county. I would like to turn the program over to County Administrator Coyle for some opening remarks.

# **County Administrator Ian Coyle**

First off, a warm welcome to this years' award recipients' friends, family and co-workers here today. This is our 20<sup>th</sup> annual event, and it doesn't happen without the work of staff; to set the room up, plan the program, order the right kind of food and I would like to thank them for that. I would like to request a brief round of applause for Melissa, Michele, Lisa and the Central Services staff. To me and to most of the Board, this is the most important meeting we have this year. This meeting represents our only dedicated opportunity to recognize the backbone of County government, the County employees. I know I speak for the entire Board when I say that we take great pride in honoring our tremendous workforce through the Employee Recognition Ceremony. At the federal and state level, I don't have to tell you that we always seem to have rigorous debate, no middle ground, perpetual disagreement and dreaded inertia on even the most trivial of matters. I would argue that we here is Livingston County stay above the fray. We keep plugging along ethically and mightily as the beacon of good government public service light in the region. And why is that? It's

because of the people in this room. It's also because of the leadership of a dedicated board willing to remove political nonsense from staffing and hiring decisions and to do the right thing at the right time for the right reasons. But chiefly it is because of the work of our incredible staff, 34 of whom are being recognized today. Every single one of our 1200+ employees is an important cog in the wheel that moves county government forward. From the elections inspector that works a few hours a year, to the nurse at the CNR caring for a resident, to mental health counselor redirecting a client from suicidal thoughts, we have representation from 8 of our 32 departments today. People that that handle, in no particular order, criminals, probationers, patients, taxpayers, county workers, residents, visitors, old, young, abled, disabled, healthy, unhealthy, the nice, the mean and some people we know can be both nice and mean. The other day my staff knows I had a lovely lady tell me I was the only thing right about government; later she told me she was the worst county official she ever spoke with. This is in the course of one day within literally, hours. We still take her calls in the office because we want to help her get whatever services she needs and you are all in this room because you have a commitment to public service. You take the calls, you answer the request for assistance and you help this county and its' people. With the aid of the County Historian Amie Alden, I always like to spice up the talk with some tidbits from life as we knew it 10 and 25 years ago. These items are from 1991 and 2006. Do you remember where you were in 2006 when Pluto was downgraded to a dwarf planet? Were you sad when Western Union decided that year to discontinue the telegraph service, no IT jokes, we do not use telegraph services. The most popular shows were "the office", which many can relate to with its workplace humor and oddball coworker characters and "desperate housewives", which I hope no one here can relate to. Locally, the Barilla plant was under construction and our Downtown Revitalization Program was just gaining significant traction. Those of you that started working here 25 years ago in 1991, operation desert storm was upon us, gas was \$1.12 a gallon and Roseanne Barr was actually popular. Locally, we were finishing this government center and in March we suffered from a devastating ice storm with County highway and municipal departments involved in clean-up efforts for months. My, how far we have come. The prices, technology and TV shows have certainly changed, but I would argue that the commitment and passion of our workforce and the people being recognized today has not waivered nor faltered. If anything, the collective power of our working hands has gotten stronger. The successes that we highlight monthly at our meetings, the awards we win regularly, the accreditations that we obtain, the grants and the project funds we have secured would be impossible to achieve had we not the dedication of a strong employee base who work day in and day out for the betterment of their fellow county residents. Our workforce realizes that we are all, in a sense, paying back the social and the civic capitol that our predecessors provided to us, to our community and to our county. The word that comes to mind during this recognition ceremony is commitment. These individuals are committed to the County and the County is committed to them. They are committed to their jobs, to the people they are serving, to doing an honest days' work and to carrying out the many functions of County government.

I want to say in closing on behalf of the Board, thank you. Thank you all for your sacrifices, for your dedication to Livingston County government. You all deserve a round of applause.
