1. Transition to new Statewide Client Database/Upcoming Challenges Timeline/Planning/Staffing/Business Associate Agreement

Ms. Davin reported that the required OFA Public Hearing will be July 27 at 10 a.m. at the Mt. Morris congregate site. There were about 24 people at last year's public hearing. Sept. 26-27 NYSOFA is coming to the office for their annual review. Ms. Davin explained some of the challenges coming up over the next the next few weeks – the NYSOFA is transitioning all 50+ counties to a common client database and from Aug. 7-Sept. 15 will be a go-dark period where they will not be able to enter anything into the new client database. During that time they do have contingency plans in place. Sept. 15 the new system will be going live and the information received during the 6 week go dark period will need to be input. She has two provisional caseworker assistant employees that took the test in April that may not be reachable on the list. She also has three people going on leave between Aug.-Oct. It is difficult to have temporary help for these positions during this time. The new system is in the health commerce system, which is a web based portal of NYSDOH and is partnering with NYSOFA on the NYCONNECTS no long door so the state DOH is contracting the state OFA and then the State OFA is contracting with each individual area OFA for this project. Because some of the information is protected health information the State DOH is having a business associate agreement with the State OFA and they are having a business associate agreement with us. The Senate appropriations bill eliminated the state health insurance information programs, which is Highcap for us. She is flabbergasted that

they eliminated that program. Congressman Collins office has called her and he knows the value of the program. They have been doing some advocacy with the senior clubs and social media. The farmer's market voucher distributions started last week. They continue to see high volume in terms of calls. Three of the six staff have completed the case management certificate program through Boston University and three more are almost through. The deadline is September. There was discussion on the matter of balance training program. Caledonia and Avon are the only sites Lifespan is willing to do at this time. She is trying to get more locations. She is hoping to offer the program at a congregate site at least once per year.

# 2. Program Updates:

SHIP funding cut in Senate Appropriations Bill (federal) – these are the dollars that support the HIICAP program (see attached). Insurance issues were top issue for seniors in Livingston County. A state and federal advocacy effort is underway to restore funding. Chris Collins' office reached out to say this is on their radar and he understands the importance of this funding.



# 3. Program Updates

Job Fair - Planning is underway for a Job Fair this September at the National War Plane Museum in Geneseo.

Health Care Forum & CNA Recruitment - A forum is being planned for mid-August to recruit candidates for an October CNA Training Program at the County Nursing Home.

Summer Employment - New worksites this summer were established at Quinlan's Pharmacy, Water & Sewer Authority, Zion House and the National War Plane Museum. 30 youth are participating in unpaid work readiness training at GCC prior to receiving summer employment. 10 additional youth are beginning career exploration at Genesee Valley Education Partnership.

Manufacturing Day - The second annual Livingston County Manufacturing Day is being planned for September.

#### CENTER FOR NURSING & REHABILITATION – FRANK BASSETT

# Pre-approved Informational Item(s) To Be Reported

- 1. FINANCIAL/OPERATIONAL UPDATES:
  - a.) Occupancy- As of June 28, occupancy was 99.0%. Year to date occupancy is 96.70%. There was a hospice patient death yesterday and an application this morning. You will see total Medicaid payer's days is down to 3.6% and managed Medicaid continues to increase each month. Very pleased with Medicare days continued growth.
  - b.) Cash Flow The CNR's Cash Flow Report as of June 27 reflects \$11,248,471.00 in reserves.
  - c.) Universal Settlement The CNR will receive \$336,389.00 in July as the 2<sup>nd</sup> payment under the agreement reached with the NYS DOH. Hereafter, payments of the same amount will be issued annually in the next 3 state fiscal years.
  - d.) IGT No information regarding CMS approval of the State Plan Amendment has been received. As of yet, there is no clear schedule for release of these funds. Bonadio & Co. was unable to include IGT non-operating income in the 2015 audited financial statements for lack of state guidance. This is anticipated to be between \$6.6-\$6.8M.
  - e.) Budget Variance The April 2016 budget variance reports will be distributed and discussed at the committee meeting. This was before the occupancy gains in May and June. You can see where budget was \$8.34M and we have revenues of \$8.4M. We have some really good controls in place on the expense side. Adult Day Care is doing well and running a high occupancy at this point at 75%. The average rehab and facility PPS rate remains very strong at \$458.72 for May. The case mix index is calculated twice a year by the minimum data sets that we submit. The case mix index is what drives the rate. Admissions have been increasing over the last two months for rehab.
  - f.) 2015 Audited Financial Statements Bonadio & Co. is concluding audit activities and will present the statements to the HS Committee at the August meeting. He received the drafts last Thursday and would like to review them before presenting at the August Human Services Committee meeting.

Mr. Bassett distributed the committee packets for review and discussion. This is the second year in the Quinlan contract and we are still seeing significant savings. Mr. Bassett presented the required annual Memorial Fund balance report. The State updated its website two weeks ago reflecting deficiencies and complaints and we had 13 standard and 4 life safety citations over the last four years. This is less that the state average of 35. There were a total of 34 complaints and of that, we self-reported greater than one-third of those complaints. Not one of those complaints resulted in a deficiency. The State complaint average is 42.

#### **Informational Item(s) Written Only**

- 1. Reports Absenteeism, Mandation, FMLA, Payroll Performance, Work Related Injuries, Quality Measures, Report Card
- 2. Advanced Training Initiative Grant The CNR has developed a preliminary schedule for PROCARE to conduct grant funded training. Pathways to Leadership will be conducted in July. The training focuses on how the customs, resources and values of an organization can be transmitted through strong leadership, management and communication skills in a way that also promotes retention of nurses and the CNA's they supervise. The grant of approximately \$305,000.00 will also enable offering training in the following: Electronic Dementia Guide for Excellence (EDGE) Training, INTERACT Stop and Watch.
- 3. EHR Reliable Health Systems continues to transition the CNR's electronic health record (EHR) and other program files from the CNR's server to a cloud-based platform. The implementation schedule for enhanced care planning, electronic medication administration record, computerized physician order entry, and progress notes is anticipated to be fully in place by the end of 2016. New Network Switches, Data Access Points, Laptop Computers, Maintenance Agreements, etc. have been ordered as part of the EHR project.
- 4. Psychological Services The CNR is exploring a Telepsychiatry option with UR Medicine, Geriatric Psychiatry Division, as a means of meeting the need for resident psychiatric consultation. The region has a significant shortage of Psychiatrists, especially those willing to serve a geriatric population. The goal of participation would be to foster behavioral interventions as an alternative to pharmacolologic interventions. Services would be rendered through video conferencing.
- 5. Flooring Project ProCarpet has not yet completed correction of all required punch list items. Clark Patterson Lee remains involved. Final payment will be withheld until all outstanding project matters are resolved to the County's satisfaction.
- 6. Bathing Suite Door Project Clark Patterson Lee has approved submittals for the project material orders have not yet been placed. Correction of the existing conditions is required by December 30.

Dining Services Production and Delivery Process Changes – Effective June 20, Morrison Senior Dining implemented changes in food production and food distribution to effect quality improvements in palatability and resident satisfaction. Food will be produced in four batches and distributed to each Household just before the scheduled meal service. This "just in time" approach should preserve food quality by avoiding degradation of textures in vegetables and meats by eliminating long holding periods.

Medical Transportation – The NYS DOH issued a Dear Administrator letter dated June 16 providing notice that with passage of the 2016/17 New York State Budget the Department will be revising the reimbursement regulations, retroactively effective April 1, 2016, to reflect the removal of medical transportation as an allowable cost reimbursable through the Medicaid rate. It is the intention of the Department to have nursing home resident medical transportation for fee-for-service Medicaid residents arranged through the State's transportation broker. Residents enrolled in a MLTC plan are to have medical transportation arranged for by their plan. This is a very problematic development given the resource gaps for transportation services in our rural community as well the ability of any transportation provider to accommodate the volume required and the 24-hr readiness to provide transportation services. Director Bassett will update the Committee on implementation planning at a future meeting.

UR Medicine Collaboration – Director Bassett has arranged a meeting at the CNR on July 6 with Dan Parr, Program Administrator for the UR Medicine Geriatrics Group and Mike Sullivan, Director of Social Work at Highland Hospital. The intent of the meeting is to discuss avenues for possible programmatic collaboration.

10. Livingston County United Way – At the June 16 Final Result's Celebration the Livingston County Employee Campaign was presented with an Award of Excellence Plus.

#### **VETERAN'S SERVICES AGENCY – JASON SKINNER**

#### **Preapproved Informational Item to be Reported:**

Mr. Skinner reviewed the CVSOA(County Veteran Service Officer Association) survey results for the Committee. This method has worked well in the past to outline every county in New York State and how they approach and provide veteran transportation. They have partnered with the VFW, the American Legion 271 and the annual airshow for a Big Band Dance fund raising event. Mr. Skinner explained that the VFW is a not-

for-profit and all funds will go through them for this event. The funds raised will be used to help gain and retain more volunteers.

# **Informational Item(s) Written Only**

I have recently returned from Syracuse. I was in training for the 3<sup>rd</sup> week of May for the American Legions accreditation. I now have one more step in the accreditation process and I will officially be a representative of the American Legions power of attorney. I hope to have the VFW's Accreditation by January of next year in order to fax directly to VA processing centers in order to expedite claims, save on paper, and postage. The VFW also supports electronic filing if we have the ability to connect using specific software that will save us \$400.00 a year in license fees. Once I have another organizations accreditation early next year I hope to be able to submit all pensions electronically to the VA to streamline and track the process much better. As it stands the ability to submit claims in this way is not recognized by the American Legion. The unfortunate part of this is that I will have to take another training that all other accrediting bodies recognize.

A new signed law allows all Veterans with the ability to buy up to three years of service towards retirement in NYS-Rules for Receiving Military Service Credit Under Article 20 (RSSL) Eligibility

# Veterans must:

- Have been honorably discharged;
- Have at least five years of credited service in the Retirement System;
- Have not received credit for this service in any other public retirement system in New York State; and
- Apply for and purchase military service credit prior to retirement.

The release of the Commission on Care report has spurred a largely divided view on Veterans Health Care. This report has been 20 years in the making. Many people will see this assessment of the VA as a recommendation to privatize the VA. This report was started many years before the Phoenix Arizona crisis caused legislation called the Choice act of 2016. In two years, the VA has spent \$2 Billion by not seeing Veterans at VA medical centers under that program.

In response to the commission's report the President of AFGE "Union" has called for nationwide rallies in order to make sure that Congress is aware that closure of any VA is not acceptable to the union. AFGE Local 3306 has scheduled its rally for 6/22 from 11AM-1PM and employees are being encouraged to join us at the front gate on Fort Hill Avenue during their lunch break to let our government know that this plan is not an option. I have a copy available for all to read if you would like it.

Many things will be taking place in July. I have set up Veterans Services 3<sup>rd</sup> in-service for a county office this year. The previous ones were for DSS and OFA. The Department of Veterans Affairs Crisis Line will be joining me in putting on a presentation for the Suicide Prevention Task Force on July 26<sup>th</sup>. Suicide is an issue among Veterans where there is support. We will be discussing those benefits that can be provided for those who served and are struggling with anything that may be contributing to their situation. To my knowledge, we have had 3 attempted Veteran suicides; one in May which left 4 children without a parent. Since I started, I have helped 9 children, who have lost a parent to an untimely death, apply for pensions. If you recall, I had reported that we had been able to obtain mental health counseling at the VA and a grant to keep her in her apartment for one of those attempts. I am pleased to report that I was able to represent this Veteran to become "Service Connected Disabled". At the 80%, we have applied for "individual employability" and IU pays at the 100% rate with one

dependent. This person will now be compensated at \$36,000.00 per year. She is now a long way from homeless and with 5 months of back pay she can now pay off a lot of bills.

Pensions for aid and attendance are taking much more time to get a VA decision. Our Claimants are getting an automated letter describing their back log of claims at the pension center in Pennsylvania. For all pensions that I have decisions on to date, I have received the maximum monetary award. This would also mean that in 8 months 4 decisions have been made out of the multitude of pensions submitted totaling \$100,000.00 for 4 full aid and attendance pensions for a Veteran. My goal next year is to have \$1Million in aid and attendance and pension claims awarded in fiscal year 2017. That could be done in 40 claims.

I have organized our counties 3<sup>rd</sup> Veterans outreach event to coincide with the Geneseo Airshow for maximum impact. Veterans outreach during the air show will include:

Veterans will need a discharge for to enroll in health benefits.

Department of Veteran Affairs Health

- ➤ Health eligibility specialists will be on hand to assist Veterans to enroll in VA Health Care.
- Counselors will be on hand to explain health benefits.

#### Department of Veteran Affairs Vet Center

- ➤ Veterans can discuss special eligibility for Vet Center services.
- > General questions about benefits can be explained.
- Can speak with VA mental health counselors if needed.

#### NY State Division of Veterans' Affairs

- > State benefits representatives will be able to answer questions about state benefits.
- > State benefits focus on employment and education.
- > Tutorial of the new smart phone app.

# American Legion / Ladies Auxiliary

> Will be on hand to explain emergency funds for Veterans families that have children.

# Veterans of Foreign Wars

➤ Will discuss military honors and offer advice on Veteran issues.

#### Veterans Outreach of Rochester

➤ Will discuss various Veteran issues.

# To compliment that event:

We will have a great time raising awareness for Veterans and the aging's need for volunteer transportation. Nearly 400 visitors have gone to the veteran's victory dance web site.

Many other counties VSO's have worked in conjunction with Veteran organizations to buy vans and fund their own volunteer based transportation network. In the last two years Orleans County has raised \$17,000. It is my hope to raise awareness and exposure for our many not for profits that have come together to meet the needs.
