AUTHORIZING LEASE WITH COUNCIL OF ALCOHOL AND SUBSTANCE ABUSE OF 5. LIVINGSTON COUNTY, INC.

RESOLVED, that the Livingston County Board of Supervisors finds that approximately 9,500 square feet located in the former Geneseo Skilled Nursing Facility is no longer necessary for Livingston County public purposes; and, be it further

RESOLVED, that the Livingston County Board of Supervisors authorizes the Chairman of the Board to sign a lease with Council on Alcohol and Substance Abuse for Livingston County, Inc. for said 9,500 square feet in the former Geneseo Skilled Nursing Facility for a period of five years commencing on September 1, 2016 and ending on August 31, 2021 at \$5,627.53 per month, increasing 3% yearly, said lease to be subject to the approval of the County Attorney and County Administrator.

Mr. Coyle reviewed the lease and explained that it is \$5,627.53 per month with a 3% increase per year. We have done a five year lease in the past. There have been challenges with the clients following the no smoking on county property policy. As a lessee, for us there are no challenges. It is simply filling vacant space. This allows for student interns to intern at any County office that we have who are involved in any program at SUNY Geneseo. This is the ongoing efforts to develop partnerships with the college. There are people ready to roll in for the fall semester.

Pre-approved Informational Item(s) To Be Reported

- 1. DISCUSSION ON PER DIEM PHYSICIAN POSITION AT JAIL-Mr. Coyle explained that this is done on a contractual basis for some time and similar to other physician positions at health department, we are moving to a part time position. Dr. Aguire has been there for some time. He is an essential figure for us. His current salary is \$120/hour and we will need to get approval for any increase. We have worked out a MOU with the union. The only change is administratively and how we do it.
- 2. DEPENDENT ELIGIBILITY UPDATE-We have finally gotten all of the unions to sign off on this and are ready to proceed. We are auditing any eligibility that someone has on the county health insurance rolls. We have very good front-end detection in the Personnel and Treasurer Offices. This will catch any relationship changes that may be missed. Typically there is an average of a 3-5% range of people that get caught in this audit. If the audit catches two of these people, it will pay for itself. We currently have approximately 750 contracts for health insurance which averages about 1700 covered lives, so 1000 of these lives are not County employees. Some employees may contact the supervisors regarding the need for this audit. He believes that marriages and/or divorces may show up more than any other types of case.
- 3. The Tax auction is this Thursday. We have not heard of any issues so far.
- 4. Consolidated Funding Applications are due Friday. We expect to have another banner year for both applications submitted and hopefully funded.
- 5. 2017 budget has kicked off. Mr. Coyle has begun the meetings with departments and not for profits. The Cornell Cooperative Extension starting it off. There was a department head meeting held was

last week.

6. Bill Bacon will be submitting a water and sewer update to the 1994 study done for County Water and Sewer Authority and municipal infrastructure. We started the process for a grant and got stifled because the scope of the project looked pretty daunting. We received word from Albany that they are looking for projects like we would be able to put together. Last week we were contacted that the Villages of Avon, Geneseo water and sewer authority and Dansville are all going to do supporting resolutions for this effort. Mr. Bacon will be sending something to Mr. Deming for action at the Board meeting. This would be about a \$300,000 grant. This grant may be able to fund something like leak detection equipment. It will also identify where we have and/or need water. Mr. Coyle reviewed various scenarios that may come out of the study.

EXECUTIVE SESSION
