Mr. Coyle explained that this will necessitate a local law. Action today would start the process at a future Ways and Means meeting to set the public hearing for the local law at a Board meeting. This would be a five year smoothing to a mix in 10% increments to experience and assessed value instead of 50/50.

Motion: Mr. Gott moved and Mr. LeFeber seconded to move forward with the local law process with introduction and a public hearing resolution Carried.

There was discussion on the special districts that have any paid employees. There was discussion on billing the towns and then have the towns do the accounting with the districts. In fifty years, there have only been two questions on this matter. Livonia has paid \$16,000 for their stipend people.

13. MODIFYING RESOLUTION NO. 2015-368: DEPARTMENT HEAD VACATION ACCRUALS

WHEREAS, the County wishes to modify when new department heads receive their first week of vacation in order to improve recruitment efforts; now, therefore, be it

RESOLVED, that effective upon adoption of this resolution the department head vacation section of resolution 2015-368 is hereby modified to read as follows:

3. Vacation.

a. Department Heads other than those listed in subsection "b" below will be provided with vacation as provided in this subsection.

Such Department Heads will accrue vacation in accordance with the following table:

Anniversary of Date of Hire	Vacation Accruals
Upon hire	5 days
1 – 10 year	15 days
11 year	16 days
12 year	17 days
13 year	18 days
14 year	19 days
15–24 year	20 days
25 year and subsequent anniversaries	25 days

A maximum of two (2) working days vacation may be held over from one anniversary year to the next. These days will not accumulate from year to year, but will be used in the new anniversary year.

Department Heads may receive payment in lieu of vacation on the same basis as provided to CSEA fulltime unit employees under the terms of their collective bargaining agreement.

b. The following Department Heads employed at the Department of Health will accrue vacation on the same basis as provided under the NYSNA contract. These Department Heads are: The Directors of Patient Services, and the WIC Program Coordinator. These department heads shall not be entitled to vacation carryover or payment in lieu of vacation unless such benefits are provided by the NYSNA contract.

c. Only vacation accrued on and after the employee's first anniversary of his/her date of hire may be payable upon termination of employment. Accrued vacation will not be payable upon termination of employment unless the requirements set forth in Article 18, §4 of the CSEA full-time employee collective

bargaining agreement are met. "Notice of termination" as used in Article 18, §4 subparagraph d shall mean when applied to Department Heads: (i) notice of disciplinary charges for those with Civil Service Law §75 or similar due process rights, or (ii) actual notice of termination for all others.

and be it further

RESOLVED, that this modification of Resolution No. 2015-368 shall be applied retroactively to fulltime department heads hired in 2016 who have not already accrued five days of vacation pursuant to the original resolution.

Mr. Coyle feels that this will make our recruitment look more appealing. He does not feel that anyone has abused this in the past, but he feels that we can benefit if we are able to offer five days of vacation at the start date instead of waiting six months.

Motion: Mr. LeFeber moved and Mr. Fanaro seconded to approve the foregoing resolution Carried.

DECLARATION OF SEQR LEAD AGENCY AND ADOPTION OF SEQR NEGATIVE 14. **DECLARATION FOR PROPOSED PURCHASE OF APPROXIMATELY .38 ACRES ON POAGS** HOLE ROAD FROM OPCO, INC.

1. NYS RETIREMENT SYSTEM BUDGET - Mr. Coyle explained that the comptroller did send information out on rate stabilization for the next year. We had forecasted some growth for the 2016 December payment and it will now be less than estimated. We will also be able to scale back slightly for the 2017 budget.

2. 2017 BUDGET UPDATE – Draft numbers will be prepared soon. For the CNR budget, the IGT payment will be about \$10M so we now need more cash to meet the 50% match obligation. The debt services left for the CNR are about \$35M. The highway budget looks good. Staffing wise, there is nothing crazy. The jail is still forecasting seven figures plus. Things are looking good. There was discussion on the impact of salaried employees. Mr. Coyle is working with Tish Lynn on this. There are quite a few people considered salary that will be moved to an hourly status. The budget workshop will be immediately following the Board meeting on October 12, 2016.

- 2. I am currently reviewing job applications to fill our vacant Real Property Tax Service Aide position.
- 3. I am also pleased to report that the Town of Conesus has filled the vacant Assessor position.
- 4. In September our office will be participating in the 2016 County Decision Makers Åg Tour, the theme this year is "Ag Assessments and How They Impact Your Community".
