<u>Director's Comments:</u> This resolution authorizes a contract between the County and the Livingston County Development Corporation to assist in community development efforts. The contract provides for downtown revitalization programming, small business assistance, entrepreneurship training, technical assistance, public relations, marketing and consultant services.

Mr. Bacon reviewed the contracts for approval. The GRE contract is a slight bump up this year. They have been a great partnership for us and have directed a lot of interest to us this year. They have received 9 leads and they have replied with 26 sites, one of which has gone quite far into the field. He explained the how the process works. The LCDC contract is the same as last year. We hope to receive some more good news on Thursday with the CFA funding awards.

Mr. Coyle reported that tomorrow is the day for the CFA funding. We have a lot of big projects slated for CFA funding and we are very hopeful of success on several fronts. Chairman Gott stated that he feels very good about the team that we have now. Bill has done a nice job in the 7 months that he has been director. The object is for Livingston County to stay in the game. Bill feels extremely well positioned to what we have to offer, especially with the 390/I90 Interstate. These are long term employers offering 100+ jobs each.

BrewInLivingston Update – There are 35 semi-finalist applications with 29 videos received back. There is a panel of 7-8 random people to view videos this Friday. There is a crash course for 3 hours every Monday night in January on licensing, business structure, etc. The person leading this class is a 30 year veteran employee of Miller Brewing Company. We are going to choose potentially four to win. Mr. Coyle believes we will have more at the end continuing toward a new business venture. There is a lot of trickle down found from this project with hops growers in the area. The applicants are well dispersed throughout the county.

Regional Economic Development Council Consolidated Funding Application awards will be announced on December 8th. The Economic Development Office submitted nine applications requesting funding for the Livonia Gateway Road, downtown revitalization, a craft brewing initiative, and several planning efforts.

Thirty-five semifinalists have been selected to advance in the Brew IN Livingston Business Plan Competition. Semifinalists have been invited to submit a 5 minute video introducing their team, business, and competitive advantage. Videos are due no later than November 30th and will be viewed by a panel of judges on December 9th.

The 2016 Sign and Façade Program awarded approximately \$70,000 to 17 projects across 7 Livingston County Downtowns. Funding is expected to leverage more than \$200,000 in private funds. To date approximately \$45,000 has been drawn down. All projects are required to be complete before year end. A final summary will be provided in early 2017.

\$50,000 in funding will be available through the 2017 Sign & Façade program. Applications will be available in early 2017.

Annual Reports from businesses receiving Empire Zone Benefits are due no later than January 6, 2017. Seven Livingston County Businesses remain zone certified. A summary of the reports including job creation and investment will be provided in early 2017.

Annual Reports from businesses receiving IDA Benefits are due no later than March 1, 2017. Thirty Livingston County Businesses are currently receiving benefits. A summary of the reports including job creation and investment will be provided early in the second quarter of 2017.

<u>Director's Comments:</u> The contract between the County and NYS Division of Homeland Security and Emergency Services for the Statewide Interoperable Communications Grant Program, Round 4 (SICG 4), was extended to December 2017, to allow for proper completion of the radio system upgrade project. Motorola and C&S Engineers will continue working with the County on the upgrade project into 2017 with no additional extra costs (beyond the original contract amounts). We expect the project to be completed in spring 2017.

These extensions allow the completion of the work due to the delay for the power hookup. National Grid completed their work yesterday. They are doing punch list items right now. She is very heavy into the deployment of radio and subscriber equipment. They have been in the process of programming, installing or distributing 1,220 pieces of equipment. Last Friday all of the portables were distributed to highway departments. The "We" working on this is the Undersheriff, Randy Worden, Bill Mann, Karen Dewar, Kevin Niedermaier, Angela and a few of her staff. They are hoping to do cut overs for portables first by the end of December but it may not be until early January. The grant extension was received and goes to the end of December.

Mrs. Ellis explained that they will be moving into the next phase for the radios with the New World upgrade as well as Interoperability in addition to the new grant that just came in for Vitale Park. It is the first of its type in NYS.

Mr. Coyle explained that Hayden Dadd already works for us as an ADA and also worked as a conflict defender with our current conflict contractor in the past.

Motion: Mr. DiPasquale moved and Mr. Gott seconded to approve the foregoing resolution... Carried.

The Clerk explained that an ad was placed in the Penny Saver in November. She did not receive any, but Chairman Gott received emails from the two currently sitting members for reappointment. There were no external parties interested.

ENERGY PERFORMANCE CONTRACT UPDATE--Rick Henry (Clark Patterson Lee) TR Cosamento & Jerry Wilson (Danforth) and Bill Cavalier (Central Services)

The County Administrator explained that we are here today to hear the end report from the energy audit of County buildings. TR Cosamento gave a brief history of the company for the committee and reviewed energy performance contracting. Energy performance contracting is a financial vehicle that allows a building owner to use future utility operational and maintenance savings for the cost of the building energy efficiency. Their goal for the County was to find systems that were older and inefficient that could be replaced and then use those savings to pay for all of the improvements. Danforth feels that there is a lot of opportunity to improve efficiencies in the Government Center. Lighting is approximately a \$1.5M project that saves \$108,390 per year in energy savings. Danforth also applies for all NYSERDA rebates available to get the best value. NYSERDA is a one-time rebate. Mr. Carman questioned the net payback and Mr. Cosamento reviewed how they Typical financing used for these projects is 15 years. There was further determined the net payback. discussion to clarify the payback. Mr. Cosamento explained that the email sent to the Committee was an earlier version. Mr. Coyle reviewed that the Committee would want to see the costs for each department area. Mr. Cosamento continued to review the report recommendations for the Committee. There was discussion on the Government Center roof age and the installation of solar panels there. Chairman Gott questioned whether the solar panels could be installed onto the new jail roof instead. Mr. Cosamento confirmed that this would be possible and we would be able to feed the jail with the kiosk panel at the Government Center. Mr. Cosamento continued through the report. Mr. LeFeber questioned what the timeframe was used for the energy cost savings. The savings listed are based upon past energy use costs. There was discussion on how inflation/deflation is determined and was that factored in. These are guaranteed savings. Danforth is responsible for any difference if the energy savings are not realized. Any excess savings goes back to the County. There was discussion on the need for an ongoing audit of energy use into the future. There was discussion on what the oldest EPC out there is and whether it's with Danforth or one of their competitors. Danforth will provide additional references from older clients to determine the continuation of energy savings. Chairman Gott questioned energy savings in equipment efficiencies when comparing Year 5 and Year 15. Danforth typically plans for one year for construction considering heating work in the summer and cooling work being done in the winter months. Lead time for some equipment is 16-20 weeks.

The County Administrator reviewed his understanding of what needs to happen next. There needs to be a payback reassessment by Danforth. See if the Medicaid savings is annual amount. A list of sample of vintage clients from Danforth. Review the financing package with the \$6.5M upfront cost. There are some funds already set aside in the CIP for items cross referenced in Danforth's report. There are some projects that need to be done in the next 12 months no matter what. There was discussion on the dialysis project, the IT upgrade work for the Board room, going paperless and the potential increase in energy usage and the trade off in savings from one area to the other. Danforth will work with the County Administrator on answering all of these questions and will place this on a future PS agenda.

There was discussion on concerns with the payback savings to the taxpayers. Mr. Coyle will be asking Danforth for end of life efficiencies and ultimate future needs. There are some improvements that are necessary regardless. There was discussion on doing this all at once, year to year or piece meal. Solar technology has been huge over the last few years. There is no good place to install something on a roof without causing problems. The Committee discussed all of their concerns on the costs, the savings and any work that could be done in house easily.

The County Administrator updated the Committee on the search to fill the vacancy for the Water and Sewer Authority Executive Director position.
