### ROLL CALL

The roll was called showing all members present except Mrs. Donohue (Conesus), Mr. Davis (Portage) and Mrs. Babbitt Henry (Springwater).

### PLEDGE OF ALLEGIANCE

The County Administrator explained that we have a new program with the Veterans Services Office called Operation Continuous Service where we try to highlight the veterans that we have working in our own County employment. We started with the Sheriff's Office and today we have Clark M. Young, Jr.:

Clark M. Young, Jr., was born in Gloversville, NY, graduating from Johnstown High School in June 1962. Following graduation from high school, Clark enlisted in the United States Marine Corps in August 1962. Upon completion of basic training at Parris Island, South Carolina, Clark Young served in Marine Air Wings in the 2<sup>nd</sup> and 3<sup>rd</sup> Marine Divisions and was promoted through the ranks to Sergeant (E-5). For his service in the Marine Corps, Sergeant Young was awarded the National Defense Service Medal, two awards of the Good Conduct Medal and Vietnam Service Medal.

Upon receiving his honorable discharge from the Marine Corps following four years, two months service in October 1966, Clark used the skills he learned in the Marine Air Wing serving as an employee of Mohawk Airlines from September 1967 to August 1970. At the same time he was employed by Mohawk Airlines, Clark served as a part-time Deputy Sheriff with the Livingston County Sheriff's Office Marine Patrol. In August 1970, he took a position with the New York State Division of Parks and Recreation in Navigation and Snowmobile Enforcement, serving there until September 1972 when he was hired as a full-time Deputy Sheriff by the Livingston County Sheriff's Office.

In January 1974, Deputy Young was promoted to Road Patrol Sergeant where he served 15 years as a first-line patrol supervisor. In December 1989, Clark was appointed Road Patrol Major, in charge of patrol services, fleet equipment, training and scheduling of uniform Deputy Sheriffs. In 1998, Major Young was awarded the Carl Draxler Award, the highest recognition given by the New York State Sheriff's Association for his exemplary service to the people of Livingston County and State of New York. Major Young retired from his full-time responsibilities in July 1999 and the very next day signed on as a Deputy Sheriff part-time where he continues to serve on the Marine Patrol and Court Security Unit. In 2001 and 2004, Clark Young was awarded Sheriff's Office Achievement Ribbons in recognition of outstanding service.

Clark resides with his wife Jane in Livonia. Clark and Jane are the proud parents of three adult sons and proud grandparents of five grandchildren.

Clark M. Young, Jr., led the Pledge of Allegiance.

The County Administrator and Chairman Gott, on behalf of the Livingston County Board of Supervisors, presented a Certificate of Appreciation to Clark M. Young, Jr.

### Clark M. Young, Jr. Comments:

Ladies and gentleman, this is an honorable thing that you are doing for veterans. I would like to recognize those from wars and conflicts that didn't come back, they're the real heroes. Those that did come back, some are handicapped, dismembered, having mental issues, but with a little thank you like this, a little something like this, it means a lot and, for them, I am proud to stand before you and accept this. What you are doing for the veterans in this community and the County definitely doesn't go unnoticed. With that, thank you again and keep up the good work. This is a beautiful county to live in, you are keeping the resources for every department, public safety is an issue and we thank you. The audience presented a standing ovation.

## LOCAL LAW NO. A – 2016 AUTHORIZING THE COUNTY OF LIVINGSTON TO SELL .546 ACRES ON BANK STREET IN THE VILLAGE OF DANSVILLE BY PRIVATE SALES

Be it enacted by the Board of Supervisors of the County of Livingston as follows:

- Section 1: The Board of Supervisors of Livingston County intend by this local law to supercede the provisions of County Law § 215 (5) and § 215 (6), which limits sales of County real property to the highest responsible bidder after public advertisement. The County of Livingston acquired 7 Bank Street, Dansville, New York (former Wilcox Press property) by tax foreclosure and had the property remediated with the assistance of a New York State grant. Three adjoining landowners and the Village of Dansville have requested small parcels from the County to clear up boundary and encroachment issues and to provide additional parking for the Village. The County of Livingston elects to supercede the provisions of County Law § 215 (5) and § 215 (6) and allow the private sales of these parcels.
- Section 2: The County of Livingston, by resolution adopted January 13, 2016, declared 4 small parcels (.546) located within the 7 Bank Street parcel in the Village of Dansville to be surplus property.
- Section 3: The County of Livingston is hereby authorized to sell said parcels to the following persons at the price set forth herein:
  - a. Tricia Anne Guerin, .359 acres, \$3,493.93;
  - b. Virginia C. VanWinkle, .074 acres, \$743.13;
  - c. James and Susan Jackson, .046 acres, \$350.00;

- d. The Village of Dansville, .077 acres, \$1,000.00.
- Section 4: This local law is subject to a permissive referendum.

Section 5: This local law shall take effect on the date of filing with the Secretary of State of New York.
