#### **INTRODUCTION OF LOCAL LAW**

#### LOCAL LAW NO. A – 2015 - A LOCAL LAW AUTHORIZING THE USE OF BEST VALUE AWARD METHODOLOGY, IN THE COMPETITIVE BIDDING PROCESS AS AUTHORIZED BY SECTION 103 OF THE GENERAL MUNICIPAL LAW AND AS DEFINED IN SECTION ONE HUNDRED SIXTY-THREE OF THE STATE FINANCE LAW

Be it enacted by the Board of Supervisors of the County of Livingston, New York, as follows:

Section 1. Name of local law

This law shall be known as the "Livingston County Best Value Competitive Bidding Law."

Section 2. Findings and Intent

The State Legislature and Governor amended General Municipal Law §103 (A08692/S6117) on January 27, 2012 to provide local governments greater flexibility in awarding contracts by authorizing the award of purchase contracts, including contracts for service work on the basis of "best value", provided that any Political Subdivision with a population of less than one million first pass a local law authorizing the use of the best value award process.

(From Assembly Bill Memo A08692) – Enactment of this legislation provides additional procurement options to localities in ways that may expedite the procurement process and result in cost savings. The "best value" standard for selecting goods and services vendors, including janitorial and security contracts, is critical to efforts to use strategic sourcing principles to modernize the supply chain and ensure that taxpayers obtain the highest quality goods and services a the lowest potential cost, while ensuring fairness to all competitors.

Taxpayers are not well served when a public procurement results in low unit costs at the outset, but ultimately engenders cost escalations due to factors such as inferior quality, poor reliability and difficulty of maintenance. Best value procurement links the procurement process directly to the municipality's performance requirements, incorporating selection factors such as useful lifespan, quality and options and incentives for more timely performance and/or additional services.

Even if the initial expenditure is higher, considering the total value over the life of the procurement may result in better value and long-term investment of public funds. Best value procurement also encourages competition and, in turn, often results in better pricing, quality and customer service. Fostering healthy competition ensures that bidders will continue to strive for excellence in identifying and meeting municipalities' needs, including such important goals as the participation of small, minority and women owned businesses and the development of environmentally-preferable goods and service delivery methods. Best value procurement will provide much-needed flexibility in obtaining important goods and services.

#### Section 3. Definitions

"Best value" means the basis for awarding contracts for purchases and/or services to an offeror who optimizes quality, cost and efficiency, among responsive and responsible offerers. Such basis may also identify a quantitative factor for offerors that are small businesses or certified minority-or women-owned business enterprises as defined in subdivisions one, seven, fifteen and twenty of section three hundred ten of the executive law to be used in evaluation of offers for awarding contracts for services.

#### Section 4. Authorization

Livingston County is hereby authorized to use best value as a basis for awarding purchase contracts and service contracts, excluding public works projects under NYS Labor Law Article 8, without regard to the amount of the expenditure, in addition to awarding such contracts to the lowest responsible bidder furnishing the required security. The County Administrator shall determine when to use best value as a basis for awarding a purchase contract and service contracts, excluding public works projects under NYS Labor Law Article 8.

#### Section 5. Requirements

Where the basis for award is best value, the County Administrator shall document in the procurement record and in advance of the initial receipt of offers, the determination of the evaluation criteria, which whenever possible, shall be quantifiable and the process to be used in the determination of best value and the manner in which the evaluation process and selection shall be conducted.

The County Administrator shall select a formal sealed competitive bidding procurement process in accordance with NYS General Municipal Law and the Livingston County Purchasing Policy and document its determination in the procurement record. The process shall include, but is not limited to, a clear statement of need; a description of the required specifications governing performance and related factors; a reasonable process for ensuring a competitive field; a fair and equal opportunity for offerors to submit responsive offers; and a balanced and fair method of award. Where the basis for award is best value, documentation in the procurement record shall where practicable include quantification of the application of the rating of proposals and the evaluation results, or, where not practicable, such other justification which demonstrates that best value will be achieved.

The solicitation shall prescribe the minimum specifications or requirements that must be met in order to be considered responsive and shall describe and disclose the general manner in which the evaluation and selection shall be conducted. Where appropriate the solicitation shall identify the relative importance and/or weight of cost and overall technical criterion to be considered by the County Administrator in its determination of best value.

The County Administrator shall develop procedures that will govern the award of contracts on the basis of best value. These procedures shall be included in the Livingston County Purchasing Policy and reviewed annually by the Livingston County Board of Supervisors in conjunction with its annual review and

approval of the purchasing policy.

Section 6. Severability

If any clause, sentence, paragraph subdivision, section or part of this law or the application thereof to any person, individual corporation, firm, partnership, entity or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, effect or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part of this law or in its application to the person, individual, corporation, firm, partnership, entity or circumstance directly involved in the controversy in which such order or judgment shall be rendered.

Section 7. Effective Date

This local law shall take effect immediately upon filing with the New York State Secretary of State.

Chairman Gott asked the County Attorney to comment on the local law.

County Attorney David Morris explained that presently, we are only authorize to award purchase contracts and service contracts when we go out to bid, to the lowest responsible bidder who provides the required security. There are several cooperative contracts out there that would allow us to purchase under them for lower pricing to us but the award of those cooperatives are not based upon lowest responsible bidder but were under the best value theory. This local law will authorize us to use best value if we determine to use it and then allow us to purchase under those cooperative contracts.

# **RESOLUTION NO. 2015-69 REQUESTING THAT NEW YORK STATE REVIEW ITS INTERPRETATION OF THE OLMSTEAD DECISION AS IT RELATES TO CHOICE OF EMPLOYMENT FOR PERSONS WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES**

WHEREAS, the United States Department of Justice and the Centers for Medicare and Medicaid Services have been working with the various states to ensure that the terms of the 1999 Supreme Court decision Olmstead vs. L.C., which requires that persons with disabilities must be placed in the most integrated settings appropriate to their needs, are enforced, and

WHEREAS, New York State believes that sheltered workshops are segregated settings and not appropriate for implementing the Olmstead decision, and

WHEREAS, the State of New York has promulgated rules wherein no new individuals may be placed in sheltered workshops and all sheltered workshops will be closed within six years, and

WHEREAS, some 8,000 individuals with disabilities are currently employed in sheltered workshops in New York State, and

WHEREAS, the State's plan is to move approximately half of those individuals into minimum wage jobs and the other half into day programs with no employment, and

WHEREAS, the individuals in the workshops currently earn less than the minimum wage based on their production capacity under the terms of an exemption in the Fair Labor Standards Act, and

WHEREAS, the State does not support paying less than the minimum wage under said exemption, and

WHEREAS, the sheltered workshops provide employment to individuals who otherwise could not be employed, and who want to continue to work there, and

WHEREAS, the State and federal government, by these rules, do not support the choice of these individuals to continue working, even though the Olmstead decision specifically states that depending on the abilities and needs of the individual, such settings are legally acceptable, and

WHEREAS, Livingston County strongly supports and advocates for the choices of said individuals and their families to work in sheltered workshops as a way to feel as and be productive citizens, regardless of abilities, and

WHEREAS, Livingston County believes the elimination of sheltered workshops would be a discriminatory and harmful action against disabled individuals, now therefore be it

RESOLVED, that Livingston County requests the State of New York consider that either workshops be allowed as a choice of employment or a model be created that promotes integration in the workshop with the support and resources necessary to make it successful and provides choice for people with disabilities as required by Olmstead, and be it further

WHEREAS, the United States Supreme Court held in *Gideon v. Wainwright* that the right to counsel for one charged with a crime is fundamental and that it is the state's responsibility to supply lawyers for those unable to afford them; and

WHEREAS, the decision to entrench responsibility at the county level in the State of New York has resulted in a system by which the County and local property taxpayers are burdened with the vast majority of the cost of this state responsibility; and

WHEREAS, the shift of costs for this state mandated service has become so imbalanced that the counties of New York now cover more than 80% of the cost burden; and

WHEREAS, implementation of the constitutional right to counsel under *Gideon* is a state, not county, obligation; and

WHEREAS, in 2006 the Kaye Commission on the Future of Indigent Defense Services declared that the New York State System of County-Delivered Indigent Services is in crisis and urged the expeditious establishment of an Independent Public Defense commission; and

WHEREAS, the State of New York and multiple counties are now defendants, and recently entered into a settlement, in the matter of *Hurrell-Harring, et al. v. State of New York*, a systemic lawsuit similar to many that have been successful across the country seeking to transform the indigent legal defense system; and

WHEREAS, the settlement will have a profound fiscal impact on the state and each and every county therein; and

WHEREAS, the state can both comply with its obligations under the settlement and significantly improve the public defense system by establishing a 100 percent state funded indigent legal defense program; and

WHEREAS, such a state funded system would relieve the counties of this state of the burden imposed upon them since 1965; now therefore be it

RESOLVED, that the Livingston County Board of Supervisors calls upon the State of New York and Governor Cuomo to immediately create a 100 percent state funded indigent legal defense and relieve the counties of this state of the burden imposed upon them since 1965; and be it further
