
Mr. Snyder explained that this position has been historically full time, but last year he filled it initially as a part time. Katherine Hilfliker has been in the position part time for the last few weeks. There has been some great success with this program.

The youth employment program has only been impacted by the increase to the minimum wage rate. The program will not be able to serve as many kids. The emergency unemployment compensation effects 230 County residents ran out of unemployment insurance on 12/31/13. The President is advocating reinstating the program today. 99 weeks is currently the maximum time that anyone has been able to be on the program. Mr. Snyder explained how a person in the employment program can work more hours and still keep some of their benefits.

5. Emergency Unemployment Compensation – On December 28th, 230 long-term unemployed Livingston County residents will lose their federal Emergency Unemployment Compensation (EUC). EUC is a 100% federally funded program that provides benefits to individuals who have exhausted regular state benefits. The EUC program has been in effect since June of 2008.

Youth Work Crew – A handful of students will be spending their winter break enhancing their employability by undergoing training and working on projects throughout the county. The students will earn minimum wage while earning certifications and developing work readiness skills under the supervision of an Employment Counselor.

Youth Bureau

6. Youth Center – The Youth Center at Goodwill will no longer be operating on Friday nights starting in January. The decision was made by the volunteer committee that operated the center based on the low turnout throughout the fall and winter. The Youth Board will look to develop other programs and activities to provide opportunities for youth to enhance their, interests, skills and abilities.

Youth Bureau – The Youth Bureau has tentatively scheduled the annual Teen Recognition banquet for Wednesday April 30th, 2014 at the River Hotel in Mt. Morris. Instructions and nomination forms will be posted on the County website and sent out in early January. Nomination forms must be returned by February 7th for consideration.

There was discussion regarding the Chlamydia numbers in the County. Ms. Rodriguez explained that there have been changes in the reporting requirements of physicians.

Informational Item(s) Written Only

- 1. The Department has had a successful flu campaign, giving 1,062 flu shots so far in 2013. We targeted 12 large clinics, concentrating on the local schools, instead of 42 as was done in 2012. Clinics were completed by November 30, 2013. The County purchased 1,100 flu doses compared to 2,400 in 2012. An effort was made this year to make better use of staff and county resources. Flu billing is going well and reimbursement is being received.
- 2. We are working on a Chlamydia QI project as our data is showing increased Chlamydia rates in the County. A physician survey was done on Chlamydia testing, and a physician tool kit was developed and distributed to local physicians. The tool kit has been well received by local physicians and health education has received calls requesting more tool kits. This can be used for a NACCHO promising intervention.
- 3. The new Springwater Water Filtration Plant was brought online in November 2013. The plant upgraded and replaced a non-compliant system that was a groundwater supply operating under the directed influence of surface runoff (GWUDI). The new plant utilizes modern technology and allows operators more flexibility to treat drinking water supply for Springwater residents under changing conditions.
- 4) The Center for Environmental Health completed Sanitary Surveys of ten community Public Water Supply Systems across the county including the new Town of Springwater facility throughout November and December 2013. The Center performs these surveys consisting of a detailed onsite inspection followed by a Report of Findings to ensure compliance with the Sanitary Code.
- 5) Linda Beuter, Administrative Secretary, is retiring on March 15, 2014, after 35 years of service.

Mrs. Deane explained the Bonadio contract helps with Medicaid cases with self employed recipients and will probably only be used until the County becomes less involved with Medicaid eligibility. Mr. Coyle explained that, every year that this contract is done, it seems as though the State is constantly trying to put more restrictions on our ability to audit who should be receiving Medicaid. Mrs. Deane described TASA (Teenage Services Act) pregnant and parenting teens. This used to be taken care of through the Department of Health before it became not Medicaidable. Money was added to the contract amount this year. There was discussion of Title 20. There was discussion regarding the TRI Group contract and Mrs. Deane explained how she reviews the history of the services to try and determine what the budgeted amount should be. The SUNY Keuka and SUNY Geneseo contracts have no cost to the county.

NYS Comptroller's audit on Livingston County Child Protective Services – Mrs. Deane reported on the Child Protective Services (CPS) draft audit findings report received from the State Comptroller's Office. The CNR has had an affiliate relationship with FLCC for seven years. This has enabled the Center to conduct two training classes annually. \$589 per participant is reimbursed through the Medicaid rate. Training costs are largely covered through workforce training grants administered by the Livingston County Workforce Development Office.

Mr. Bassett explained that this contract is an affiliation agreement, which enables the nursing home to act as a campus for the purposed of conducting the home health aide program. Their coordination problems have been cleared up since last year.

- 1. FINANCIAL/OPERATIONAL UPDATES: Mr. Bassett distribute an informational packet for discussion. The facility has been 100% occupied for every day of 2014. The facility was 100% occupied for 40 days in 2013 compared to 12 in 2012.
 - a.) Occupancy- December occupancy was 98.96%. YTD occupancy has averaged 98.78%. This occupancy level is the highest in the 8-year history of the CNR's operation. Registrant occupancy in the Garden of Life ADHC Program was also the highest since opening the CNR in December 2005.

- This is a model program in the State.
- b.) Cash Flow The CNR's Cash Flow Report as of December 30, 2013 reflects a balance of \$6,681,685. 2013 EOY cash balance is \$1,374,037 better than EOY 2012. The cash gain is attributable to increased occupancy and higher Medicare utilization. All due to county 2013 obligations, i.e., retirement, health insurance and Worker's Comp through November have been paid. He is excited for where the facility is going in 2014. Transitional care is maxed out at 26 beds every day. They will be proceeding with a Transitional Care Unit 2 and, if successful, they will implement a Transitional Care Unit 3.
- c.) Budget Variance and Census The October 2013 budget variance reports are attached and will be discussed at the committee meeting. Revenues are much stronger due to the high occupancy rates.
- 2. IGT (InterGovernmental Transfer funds) IGT monies related to this anticipated distribution were not received in 2013 but are likely to be received by March 31, 2014. The 2011/12 IGT was received in February 2013 totaling \$4,440,490.
- 3. Medicaid Managed Long Term Care (MMLTC) Implementation of the transition from fee-for-service Medicaid to Managed Medicaid enrollment has been moved from July to September 2014. Residents in the nursing home as of September 1 will not need to enroll but all newly admitted dual eligibles (Medicare/Medicaid) would have to. Negotiation of contracts with MMLTC providers remains paramount in the coming months to insure we are able to admit individuals from as many plans as possible. This transition will similarly affect registrants of the Garden of Life ADHC Program.

 Transitional care is maxed out at 26 beds every day. They will be proceeding with a Transitional Care Unit 2 and, if successful, they will implement a Transitional Care Unit 3.
- 4. Employee Time Keeping Effective December 29 the central time clock in the employee entrance was replaced with 9 time clocks, one on each of the six Neighborhoods, one in the Maintenance Shop, one in the Garden of Life and one in Fiscal/Administration for hourly employees to swipe in/out within their assigned work location. This change is a proactive measure to strengthen the integrity of the CNR payroll process. Staff response has demonstrated widespread staff acceptance and compliance. Dale Nieswiadomy was instrumental in assisting Maintenance and Fiscal staff with implementing this change. The timekeeping process will be evaluated further for greater ease of use by staff. There are still some problems with this and he has put additional signage up and has identified those employees with problems with their badges.

Informational Item(s) Written Only

- 1. Reports Absenteeism & Mandation, FMLA, Payroll Performance, Report Card
- 2. Labor Hours Increased occupancy in 2013 required labor hours to increase. Total regular hours in 2013 increased by 6,254 while overtime was reduced by 232 hours. Total labor costs were approximately 1.76% higher in 2013 attributable to the increased regular hours worked and the negotiated 1.5% salary increase.
- 3. Transitional Care Unit II The CNR management team is developing a plan for expanding Transitional Care services. A 12-bed Family Unit in a Traditional Neighborhood will be converted from chronic care to transitional care through resident attrition. This will increase opportunity to provide additional rehab services and increase Medicare utilization.
- 4. Registered Nurse Recruitment The CNR is still struggling to attract Registered Nurses. The following vacancies need to be filled: One full time Charge Nurse day shift, part time evening and night shift RN for TCU, and every other weekend evening and night shift Charge Nurse. These needs are driven by the CNR's commitment to having two RN's in the building 24/7 to manage the increasing acuity associated with transitional care and sub-acute care patient types.
- 5. Capital Project: Carpet Replacement project Clark Patterson Lee is working with the CNR to develop and issue a bid for replacement of all carpeting in resident care areas. Carpet has a depreciable life of 5 years; existing carpet is now over 8 years old. Various options are being explored to minimize project

- cost, maximize reimbursement and facilitate ease of floor maintenance. A single Family Unit will be installed to model a sheet vinyl and carpet option for staff, resident and guest feedback. This is a budgeted 2014 project.
- 6. Work Plans Director Bassett will conclude meetings with all CNR Department Heads in January to finalize the CNR's 2014 Work Plan. This plan will be distributed to the Human Services Committee in Q1 2014. Strategic initiatives include addressing the following: service & payer mix, revenue optimization, labor & other expense control, workforce development & retention, and regulatory compliance.
- 7. Holiday Activities Numerous school districts, civic, and religious groups visited residents of the CNR for caroling and entertainment throughout the month of December. Through efforts of various groups all residents received gifts.
- 8. County Worker United Way Campaign The CNR will host the Campaign Coordinator kick-off luncheon on January 30. The County Worker campaign will run from February 3 through March 3, 2014. Campaign Coordinators will set the fund-raising goal when they meet. In 2013 employees raised over \$38,000.

VETERAN'S SERVICES AGENCY – FRANK HOLLISTER Informational Item(s) Written Only

- 1. At the quarterly meeting of the Veterans Advisory Council, held at the Buffalo VAMC on December 13, 2013, the tentative budget for fiscal year 2014 was discussed and any "shortfalls" that may take place. At this time, all looks good for the entire VA system, but the federal government may again sequester VAMC employees. The Buffalo VAMC will be receiving a new M.R.I. in the near future as well as a C.A.T. scan. In 2014, the Buffalo VAMC will also start placing cochlear implants for veterans who have totally lost their hearing, prior to this, veterans had to go to Washington, D.C. for the procedure.
- 2. I have attended several meals-on-wheels sites provided by the Office for the Aging. I have met several new, potential clients, renewed friendship with several present clients, provided information to those in attendance plus enjoyed terrific meals. The seniors from the meal site in Mt. Morris donated almost three hundred (300) Christmas cards that my American Legion Post sent to units we sponsor in Afghanistan. After the first of the year, I plan on visiting the meal sites in Avon and Dansville.
- 3. I approached the guidance staff at Mt. Morris Central School and asked/requested them to have the students in both the Elementary and High Schools to make Christmas cards for our troops in

- Afghanistan. Within a week, my contact at the school dropped off several envelopes full of cards that my American Legion Post mailed to Afghanistan.
- 4. During the month of December, I participated in approximately eight (8) hours of training on how to enroll a veteran into the "ebenefits" program. If a veteran is not enrolled in "ebenefits", neither the veteran nor this Service Officer can track his or her claim through the system.
- 5. Also during the month of December, this Service Officer and Service Officers nation wide are participating in the Stakeholder Enterprise Portal (SEP), the VA's new system for filing claims on line. This training is offered every Thursday afternoon, but unfortunately, they (the VA), has yet to work out the "bugs". It may be a good system in the future, but presently, it has a long ways to go and numerous accredited Service Officers in New York refuse to participate.
- 6. The VA recently added five (5) more condition related to traumatic brain injuries. Unfortunately at this time, we have one local Afghanistan veteran who has been exposed to three (3) T.B.I.s, and is having a very difficult time.
