A small company that has outgrown their space and is looking to purchase two acres in the Avon Industrial Park. They will be almost doubling their workforce. Because two of the awards came to Livingston County we need a resolution to enter

into contract with New York State Housing Trust Fund Corporation for those grants and then secondly resolutions with Livingston County Development Corporation to do all of the grant administration.

ECONOMIC DEVELOPMENT

Please hold open Friday, February 6, 2015 for the Economic Development Annual Report. (Note the date change due to NYSAC Conference.) The event will take place at 4 PM in Geneseo. More details to follow.

Regional Economic Development Council Consolidated Funding Application awards were announced on December 11th. The Economic Development Office submitted applications for 10 potential projects; 2 NY Main Street applications, 2 NY Main Street Technical Assistance applications, 1 NY Main Street Anchor application, 1 small business, 2 economic development, and 2 strategic planning applications. Nine (9) of the projects were awarded funding. The Main Street Anchor Project (Geneseo) and the 2 New York Main Street applications (Dansville and Mt. Morris) were combined into a single award of \$500,000. Livingston County communities received several other awards infrastructure and planning projects. Additionally, the Finger Lakes Regional Planning Council (GFLRPC) received a \$3,000,000 award to establish an agricultural-economic development revolving loan fund. Funding allocations to each county are based on the agricultural census. As loans are made by GFLRPC, they are repaid to the Livingston County Development Corporation Revolving Loan Fund. The repayments will be segregated from the existing small business loan fund and will be used to fund agricultural-economic development projects.

IDA

In addition to the Consolidated Funding Application awards, \$200,000 was awarded by NYSDOT to the Livingston County IDA to assist American Rock Salt with the expansion of the rail line at the Town of Groveland facility.

The IDA has accepted a purchase offer from the Village of Mt. Morris for an approximate 2 acre parcel in the Mt. Morris Industrial Park.

The IDA has accepted an application for assistance from Coast Professional for an approximate 15,000 square foot expansion to their Geneseo facility. The project proposes an investment of \$4.8 million, creating 85 new jobs and retaining 175 jobs. The public hearing was held on December

23rd.

The IDA has also accepted an application for assistance from 5638 Tec Drive LLC (DP Tool) for an approximate 28,000 expansion to their Avon facility in the Crossroads Commerce Park. The project proposes an investment of \$4.2 million, creating 17 new jobs. The public hearing was held on December 23rd.

All Town and County PILOT billings have been prepared and sent to the County Treasurer, Town Clerks and Supervisors.

<u>LCDC</u>

The 2012 New York Main Street awards for the Village of Avon and the Village of Nunda expired in December and were completed on time and on budget. Both commercial and residential units renovated exceeded the grant requirements. Each community received a \$250,000 grant award which assisted a total of 42 projects, leveraging \$500,000 additional private investment.

Applications are now being accepted for the 2015 County Sign & Façade Improvement Program and will continue to be accepted throughout the year. Information has been sent to all business and building owners in the designated downtowns.

Mrs. Ellis reported that they have a lot going on with a lot of new projects crossing over a lot of different agencies this year. There was discussion of the three new tower site options in the county (Springwater, Nunda and Caledonia).

COUNTY PROJECTS:

LIVINGSTON COUNTY EMERGENCY COMMUNICATIONS PLAN:

The consultant team continued work on the radio system design. The 911 Committee met on December 17, 2014, to hear presentation on the system design and suggested locations for 3 new tower sites. The next Project Management Team meeting is scheduled for January 21, 2015.

COUNTY TRANSPORTATION CONNECTIVITY PLAN: The three work groups (Public Transportation, Community Development, Environmental) met the first week of December to start the Plan implementation process.

DANSVILLE TRANSPORTATION AND INDUSTRIAL AND COMMERCIAL ACCESS STUDY: The consultant team continued work revising the draft Plan document.

COUNTY PLANNING BOARD:

Vacancies. There are 3 vacancies on the Planning Board – 2 for Alternate At-large members; 1 for North Dansville.

AGRICULTURAL & FARMLAND PROTECTION BOARD (AFPB):

FY2008-2009 Farmland Protection Implementation Grant (Triple H and Sunny Knoll farms). The Genesee Valley Conservancy continued work on these projects. These projects are scheduled for close-out in 2015.

Agricultural District Renewal. The renewal package for Agricultural District #3 was sent to NYS Agriculture and Markets as approved by the Board of Supervisors. We are waiting to hear back from the State on acceptance of the submission.

303b Petition Process. Section 303-b of the New York State Agriculture and Markets Law provides for the inclusion of viable agricultural land within a certified agricultural district prior to the county established review period. The petition package was submitted to NYS Agriculture and Markets as approved by the Board of Supervisors on November 19, 2014. We are waiting to hear back from the State on acceptance of the submission.

UPCOMING TRAINING OPPORTUNITIES:

LET'S Plan. Reminder: Evenings with the County Planning Board is an opportunity for municipal training credit hours. Municipal planning and zoning officials may receive credit for attending and learning about County Planning Board review. Those interested should call the Planning Department beforehand to learn about the agenda and ensure that a meeting is being held. Meeting cancellations are rare, but do happen. We are currently working on the training program for 2015.

CONESUS LAKE WATERSHED MANAGEMENT PLAN (CLWMP) – CONESUS LAKE WATERSHED COUNCIL (CLWC):

Streambank Remediation Projects – Phase I (\$382,869) & Phase II (\$358,132):

The consultant team continued work on final designs, state and federal permitting, and coordination with landowners. Work on lower Long Point, Geneseo is almost complete. The remaining work for the Town of Livonia and Geneseo will commence in Spring 2015. Conesus Lake Watershed Council.

TMDL. The Planning Department staff attended the NYS DEC public meeting on December 15th on the development of a Total Maximum Daily Load (TMDL) for Conesus Lake. Staff provided comments and presented a box of materials created through 10 years of work on the Watershed Management Plan.

E911 ADDRESSING:

The Planning Department continued work on the E911 addressing assignments and ROW naming with the Sheriff's Office.

ENVIRONMENTAL MANAGEMENT COUNCIL:

The Council discussed the 2014 annual report and work plan for 2015 at its November meeting. The next meeting will be held on January 28, 2015.

DISTRICT ATTORNEY – GREG MCCAFFREY

Pre-Approved Informational Items:

1. District Attorney Investigator – Discussing need to add a part time DA investigator

Mr. McCaffrey explained that Livingston County is one of the few District Attorney offices in the state that does not have an investigator. The position has funds budgeted in 2015. The position is a supplement to the Sheriff's Department and county agencies. He plans to use the investigator due to increasing demands on his time, due to among other things the drug task force work that he currently spends many hours per week monitoring. He does have a specific person in mind, but has been approached by several people interested in the position. He is looking for someone with extensive knowledge and experience in narcotics, for example to help take the drug task force to the next level. The person he has in mind for this position has over 35 years of narcotics experience. He was the senior most narcotics investigator in the state. He would be a huge asset to the County. He sees them doing more with wire taps, warrants and possibly trying to seize a house down the line. Usually police offices draft search warrants, but that is not the case in Livingston County. They have been doing a lot of tracking cell phones during investigations. This position would do additional investigative work, could use one of their vehicles for travel, etc. He has spoken to the Sheriff and all of the Police Chiefs and they feel okay with the person he hopes to have fill this position. He anticipates 15-20 hours per week, with 30 hours per week to start, but the annual salary needs to be less than \$30K because of retirement and budget restrictions. There was discussion regarding any grant funds for this type of position. There is drug forfeiture money that he will need to check if any of those funds are available and see if it can be used to fund this position. Mr. Coyle will check into the requirements and restrictions but stated that is not part of the discussion. Steuben County did a District Attorney drug initiative, brought on a part time investigator to serve the drug task force and basically serve as a liaison to all of the police agencies to put the program together. Their drug task force is different than ours as it is set up directly through the District Attorney's office that now has three part-time investigators. Mr. McCaffrey has talked to the task force and they support the need for more manpower.

The committee felt that this is an important position. Mr. Coyle will check on if this will need to go to the Ways and Means Committee for the salary but he approves part time positions.

There are a few things that have contributed to theses increases. Primarily, we have a new sheriff who has been very busy with drug stops and the drug task force, numbers are increasing. Family Court continues to increase. She has received \$2,667 and has received \$519.25 from her collection agency.

She is here to report on the grant/distribution from the state. This money has been used for last five years to replace money the state used to give us. Each grant is a three year grant overlapping each grant the following year. The first grant came in four years ago and was for 25% of what the state took from us. A year later the second grant came out for 25% and the third grant for another 25% a year after that. Last years' grant came out for 25% and we now have 100% of money the state took from us. Now grant 1 has expired because it has been three years. Grant five came out a week ago and instead of being 25% is 50% so instead of \$101,000 it is \$203,000. Instead \$33,000+ per year it is \$67,734 per year just for these three years. Mrs. Tetamore explained that they are recommending that she take half of this grant and put it toward grant 2 for salary payments. This amount goes back to 25% next year. Mr. Coyle explained how we receive a straight \$150,000 check five years ago from the state to offset whatever we spent for public defense. Then they made you augment what you did, say a baseline of \$1M, they wanted you to spend another \$50,000 enhancing public defense services in your county somehow, then they would give you \$50,000. They took it away, then said to get one piece back, you need to spend more money. They are now making this more of dollar for dollar. Mrs. Tetamore has used this money for computers, desks, file cabinets, books, software, space and positions. Mrs. Tetamore explained that she has hired David Hoffman to handle night court issues under the grant fully paid for three years. Her office is staffed by three full time attorneys and three part time attorneys. She is the only criminal attorney. She needs another full time criminal attorney to help her with the felony criminal stuff. She would like to use this grant to

hire a full time criminal attorney. The grant has the potential to cover almost all of the costs for a new position if we used the entire grant. She needs someone with some felony experience. This grant started 1/1/15 and runs through 12/31/17 but she can apply for an extension if a new attorney is not hired for a few months. This money is more like state aid reimbursement than a grant. Mr. Coyle explained that he will meet with Marcea to prepare what the FTE count, staffing and fiscal parameters look like with Hoffman in the mix now to give the Committee a better picture of what the grants look like, what the cost would be for any addition for further discussion at the next Public Services Committee meeting on January 29, 2015.

1. Meetings were held in December in the towns of Avon, Caledonia, Conesus, Geneseo, Groveland, Leicester, Lima, Livonia, Mt. Morris, North Dansville, and York for the purpose of consolidating the election districts. Nunda, Sparta and Springwater did not want meetings but advised us of their changes, Ossian, Portage and

West Sparta did not require any changes. A second meeting has been scheduled for Conesus on January 5th. The proposed changes are as follows:

- 2. A state wide conference call was held on December 18th with the State Board. They have certified the election results. Two new political parties will now be recognized by the State giving the voters 8 choices to be registered in a party. The 2 parties will need to organize to elect officers and confirm their official party names. All forms will need to be changed to list the 8 parties and the correct order.
- 3. The NVRA purge of voters allowed 1,478 voters to be cancelled in December. These voters had been in inactive status and had not voted in 2 Federal elections.
- 4. Year–end statistics were compiled for the report as required by the State Board of Elections and completed as requested on December 30th.
- 5. The NYS Election Commissioners' Association conference is January 12-15, 2015 in Albany NY. The Commissioners and Deputy Commissioners will be attending.
- 6. Village caucuses will be held January 20th through 27th. Elections will be held in the villages of Dansville, Livonia, Mt. Morris and Nunda on Wednesday, March 18th, 2015.
