AUTHORIZING THE IMPLEMENTATION AND SUPPLEMENTAL AGREEMENT WITH NYS DEPARTMENT OF TRANSPORTATION FOR PRELIMINARY ENGINEERING, DESIGN, CONSTRUCTION, CONSTRUCTION INSPECTION AND CONSTRUCTION SUPPORT PHASES, AND FUNDING IN THE FIRST INSTANCE 100% OF THE FEDERAL-AID AND STATE "MARCHISELL" PROGRAM-AID ELIGIBLE COSTS, OF A TRANSPORTATION FEDERAL-AID PROJECT (PIN 475559), AND APPROPRIATING FUNDS THEREFOR: BRIDGE PREVENTIVE MAINTENANCE PROJECT

WHEREAS, a project for the Preventive Maintenance on Four Bridges (now Two Bridges), Livingston County (NYSDOT PIN 475559) (the "Project") is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs of such program to be borne at the ratio of 80% Federal funds and 20% non-federal funds; and

WHEREAS, the County of Livingston desires to advance the Project by making a commitment of 100% of the Federal and non-Federal share of the costs of the Engineering, Design, Construction, Construction Inspection and Construction Support phases; and

WHEREAS, Livingston County Resolution No. 2011-280 authorized and funded a total of \$62,000.00 for Preliminary Engineering and Design phases, now, therefore be it

RESOLVED, that the Board of Supervisors, duly convened, does hereby approve the above-subject Project, and be it further

RESOLVED, that the Board of Supervisors hereby authorizes the Chairman of the Board to pay in the first instance 100% of the Federal and non-Federal share of the cost of all phases of the project, including: Engineering, Design, Construction, Construction Inspection and Construction Support phases for the Project or portions thereof, and be it further

RESOLVED, the total sum of Six Hundred and Sixty-Four Thousand, Eight Hundred and Thirty-Five Dollars (\$664,835.00) (of which, with anticipated Federal Aid and NYS Marchiselli Aid, the County share will be approximately \$180,050.00) is hereby appropriated from the Board of Supervisors and made available to cover the cost of participation in all phases of the Project, and be it further

RESOLVED, that in the event the full Federal and non-Federal share costs of the Project exceeds the amount appropriated above, the Board of Supervisors shall convene as soon as possible to appropriate said excess amount immediately upon notification by the New York State Department of Transportation thereof, and be it further

RESOLVED, that the Chairman of the Board of Supervisors be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or Marchiselli Aid on behalf of the Board of Supervisors with the New York State Department of Transportation in connection with the advancement or approval of the Project, and providing for the administration of the Project and the Municipality's first instance funding of project costs and permanent funding of the local share of Federal-aid and State-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible, and be it further

RESOLVED, that a certified copy of this Resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project, and be it further

RESOLVED, that this Resolution shall take effect immediately.

D. Higgins explained this contract covers various repairs and maintenance work on bridges in Avon and York. He indicated that Hunt Engineers is the engineer designer on this project. This agreement includes the engineering, design, construction and construction inspection. D. Higgins indicated that the total is just under \$665,000—currently the local share is \$180,050, which looks high because typically our local share is not that much. D. Higgins explained this particular agreement is based on the original funding amount that was approved two years ago. We have to show that amount for this particular agreement but there will eventually be a supplemental agreement. Bids were opened last Wednesday, and on Thursday the Genesee Transportation Committee (GTC) met and GTC voted to award \$200,000 more in funding toward this project. This process will take a few months and then DOT will provide another agreement. For now, it will show this local share but eventually it will get down to the 5% level.

COUNTY PROJECTS:

LIVINGSTON COUNTY EMERGENCY COMMUNICATIONS PLAN:

Intertech Associates provided presentation on the Final Plan on April 16, 2013.

Next Steps: The Project Steering Committee will meet to discuss next activities. The Sheriff's Office has already started the process for securing frequencies and has been monitoring channels for potential issues. Sheriff's Office and Planning Department staff met as a follow-up to the meeting with the NYS Division of Homeland Security on the SICG-2 Grant Round for actions necessary to strengthen the County's application for the next round of funding.

COUNTY TRANSPORTATION CONNECTIVITY PLAN: The consultant team continued work on the

project. The consultant has revised the draft Existing Conditions Report. The report is posted on the County's website. Draft Technical Memorandum #2: Needs Assessment has been provided to the County for review. The Project Steering Committee met on April 19, 2013, to conduct a peer review. Comments will be provided to the Consultant. We are targeting the next public meeting for input on the Needs Assessment for May/June.

COUNTY PLANNING BOARD:

Vacancies. There is one vacancy on the Planning Board – one for an Alternate At-large member.

AGRICULTURAL & FARMLAND PROTECTION BOARD (AFPB):

FY2008-2009 Farmland Protection Implementation Grant (Triple H and Sunny Knoll farms).

The Genesee Valley Conservancy continued work on these projects.

Agricultural District Renewal. The first mailing for Agricultural District #2 is planned for Spring 2013. Staff continued work on preparing the mailing. The pre-mailing data report has been prepared and circulated to NRCS, Soil and Water Conservation District, Farm Services Agency, Cornell Cooperative Extension and the affected assessors for review.

UPCOMING TRAINING OPPORTUNITIES: LET'S Plan

TRAINING REQUIREMENTS: The schedule for this year's programs is finalized and includes presentations on green infrastructure, historic preservation for downtown buildings, transportation planning/walkable communities, and agricultural districts. Reminder: Evenings with the County Planning Board is an opportunity for municipal training credit hours. Municipal planning and zoning officials may receive credit for attending and learning about County Planning Board review. Those interested should call the Planning Department beforehand to learn about the agenda and ensure that a meeting is being held. Meeting cancellations are rare, but do happen.

CONESUS LAKE WATERSHED MANAGEMENT PLAN (CLWMP) – CONESUS LAKE WATERSHED COUNCIL (CLWC):

Streambank Remediation Projects –Phase I (\$382,869) & Phase II (\$358,132: The consultant team continued field data collection and survey work. They continued work on design of the alternatives for remediation.

Conesus Lake Watershed Council. The next Council meeting will be held on May 10, 2013. Action items include: Approval of the update of the Conesus Lake Watershed Characterization Report; Acceptance of the Annual Report of the Watershed Inspection Program, and; Approval of the Invasive Species Prevention and Response Plan.

Conesus Lake Watershed Council – Technical Committee. The Committee met on March 22, 2013. The next meeting is scheduled for April 26, 2013.

Conesus Lake Watershed Council – Agricultural Committee. The Committee will be meeting on April 24, 2013.

Update of the Conesus Lake Characterization Report. Planning staff and EcoLogic continued work on the Conesus Lake Watershed Characterization Report planned for approval by the Conesus Lake Watershed Council on May 10, 2013.

TRANSPORTATION:

Genesee Transportation Council: The next Council meeting is scheduled for June 20, 2013

Genesee Transportation Council Planning Committee: The Planning Director attended the Planning Committee meeting on April 11, 2013. The next meeting is scheduled for May 23, 2013.

GENESEE-FINGER LAKES REGIONAL PLANNING COUNCIL:

Executive Committee. The Planning Director attended the meeting on March 14, 2013. The next meeting is scheduled for May 2, 2013.

Planning Coordination Committee. The Planning Director attended the Planning Coordination Committee meeting on April 5, 2013. The next meeting is scheduled for June 7, 2013.

GENESEE FINGER LAKES REGIONAL SUSTAINABILITY PLAN PROJECT: The Planning Director continued to participate on the Planning Team for the project. The Final Plan was submitted to NYSERDA on March 31, 2013 as required. The Planning Team has been working on

revisions to the Plan per comments by NYSERDA. The Plan will be presented to the Finger Lakes Regional Economic Development Council on May 3, 2013.

E911 ADDRESSING:

The Planning Department continued work on the E911 addressing assignments and ROW naming with the Sheriff's Office.

WEATHERIZATION ASSISTANCE PROGRAM (WAP):

Planning Department staff and the NYS Office of Community Renewal continued working on the necessary steps to close out the program on March 31, 2013. The Planning Department and representatives from the Wyoming County Community Action Agency continued to coordinate transfer of the program. The Livingston County Planning Department is scheduled for audit on April 29, 2013. We are working on the final list of materials and equipment that would be transferred to WCCA, retained by the County, or disposed of.

ENVIRONMENTAL MANAGEMENT COUNCIL:

Earth Day Award. SUNY Geneseo was selected as this year's recipient of the award. Presentation will be at the April 24, 2013, Board meeting.

Director's Comments:

Caseload Explorer is developed by AutoMon of Scottsdale, Arizona, and configured for New York in conjunction with the NYS Division of Probation and Correctional Alternatives (OPCA). Currently, the system has been implemented in approximately 50 county Probation Departments across New York State. Other programs that probation officers use daily are being integrated into Caseload Explorer.

This money is in the 2013 budget in the amount of \$15,518.14. The proposal was originally quoted at \$15,518.14, but then realized that AutoMon had Livingston County Probation Department budgeted for 13 employees and not 14, which resulted in a slight increase of \$182.50 over the budgeted first year amount.

L. Mignemi explained this contract is for Caseload Explorer, which is a case management software system. This software has been around for a long time and supports day-to-day Probation functions—financials, supervision, investigation and over the last few years they are interfacing a lot of functions such as the Integrated Probation Registrant (IPR) System. Every adult on Probation is registered with the Division of Criminal Justice Services. This new software will almost register the offenders automatically. L. Mignemi indicated she would like the Probation Department to begin using this software system.

The County Administrator noted that the County is paying approximately \$15,000 a year for the service. He explained that he and Lynne talked about this at budget time a few years ago, and he indicated it warrants our participation and he strongly supports entering into a contract with AutoMon.

Mrs. Babbitt asked for a clarification on the amount that was budgeted. The County Administrator stated the budgeted amount was \$15,518 and the cost is \$15,700 and the difference will be paid out of funds within the Probation Department budget at the end of the year.

He stated we received a quote from MEGA and what this company does is obtain a price from companies as well. OTHER – IVAN DAVIS REPRESENTING FISH & WILDLIFE MANAGEMENT BOARD

Action Item(s) To Be Reported

1. AUTHORIZING USE OF RIFLE IN LIVINGSTON COUNTY FOR DEER & BEAR

Portage Supervisor Ivan Davis and a representative on the Fish & Wildlife Management Board stated he is here today to ask if the Board of Supervisors would authorize the use of rifle in Livingston County for deer and bear. He stated that most counties in the State have authorized the use of rifle. He added it has been proven that rifles are safer than shotguns. Rifles usually have one shot and shotguns have up to six shots. The use of rifle is allowed year round for woodchucks and coyotes. Mr. Davis asked if anyone had any questions. He indicated that he spoke with Public Services Chairman Gerald Deming on the telephone and explained some of the rules and regulations to him. Ducks cannot be shot with a rifle, a hunter cannot shoot within 500 ft. of a dwelling or at the road. Everything is the same except this would allow hunting deer and bear with a rifle. Mr. Davis recommended that this committee authorize the use of rifle and refer this action to the full Board.

The County Administrator stated if the Board approves then it is referred to the State Legislature for approval.

Mt. Morris Supervisor DiPasquale asked Mr. Davis if he has talked to any farmers on this because he has heard some are opposed, and Mr. Davis stated that most farmers support this. Farmers are already allowed to shoot deer with a rifle with a nuisance permit even at night.

Mr. Deming commented that when this issue was addressed a few years ago, there was a lot of controversy at that time. He recalled a lot of farmers being opposed to this and especially a lot of York, Geneseo and Livonia town residents. Mr. Deming added that a lot of people didn't think it would be safe while hiking on the Greenway Trail. Mr. Davis indicated that statistics show there are less accidents now in those counties that are hunting with rifles.

Mr. Mahus stated that Ontario County has introduced their request to Albany twice and Wayne County cannot get enough nuisance permits to take care of the deer population. Mr. Davis indicated that Stein Farms have brought in 30 nuisance deer to his business and all 30 deer were shot with a rifle.

Mr. Mahus stated that the Board would have to approve the use of rifle and then it gets referred to the State Legislature and they would have to enact legislation authorizing the use of rifle. Mr. Mahus questioned why the State doesn't authorize it on a State level and be done with it.

The County Administrator asked if Ontario County requested permission for the entire County. Mr. Mahus stated he believes that Ontario County initially authorized south of Route 20 and then they submitted a request for the entire county, and he is not sure if they have changed it since then.

Mr. Deming stated that a few years back we were also discussing the use of rifle in certain areas of the County. Currently, Steuben, Allegany and Wyoming Counties have been approved for the use of rifle throughout the County.

Ossian Supervisor Martello stated this is one of those issues where we will find people on either side of the fence. Mr. Martello stated that Ossian is very rural and knowing this issue was on the agenda he stated he took the opportunity to ask 15-16 people and there are as many against it as there are for it. Mr. Davis stated he believes the people that are against it do not understand what they can and can't do. Mr. Deming stated he doesn't agree with that. He believes either you are for it or against it. He stated that someone could tell him everything good about it and another could tell him something bad about it, and he is opposed to it and would not listen to the good facts. Mr. Deming stated it is similar to fracking—some are for it and some are against it.

Springwater Babbitt Henry stated that an unsafe hunter is still an unsafe hunter no matter what weapon is in their hand.

Mr. Deming asked what the Committee's preference is. Mr. DiPasquale suggested to take the matter to the full Board.

The Clerk asked if the Committee is supporting this and referring their recommendation to the full Board or does the Committee want the full Board to decide on the matter.

MOTION: Mr. DiPasquale moved and Mr. Martello seconded to refer this matter to the full Board to decided on what action to take. Carried.

2. LCDC – Downtown Coordinator, Louise Wadsworth attended the annual National Main Street Conference in New Orleans, LA. Her written report is attached.
3. FINGER LAKES REGIONAL ECONOMIC DEVELOPMENT COUNCIL - The Council will meet on Friday, May 3rd to review the work plans of the 11 workgroups. It is anticipated that Consolidated Fund Applications will be made available in May with applications due in mid-July. Economic Development Staff are planning for applications that will be submitted by the department.
4. FOREIGN TRADE ZONE WORKSHOP – the Foreign Trade Zone information session scheduled for April 9th was cancelled due to lack of interest. Economic Development staff will discuss the benefits of international trade and the foreign trade zone during Business Retention & Expansion visits with companies.
5. NEW YORK MAIN STREET PROGRAM - 14 applications totaling over \$500,000 in requests for New York Main Street funding were received from property and/or business owners in Avon. Application review and award recommendations will take place on May 2nd.
Applications for New York Main Street funding in the Village of Nunda are due April 26th. Review and award recommendations will take place May 9th.
Reminder notifications were sent to Village of Geneseo building/business owners. Six months remain to complete their awarded projects.
6. DOWNTOWN REVITALIZATION PROGRAM - The County Sign & Façade Improvement Program received 42 applications totaling over \$155,000 in funding requests. These requests far exceed the \$55,000 that was budgeted for awards. The application review committee recommended that the LCDC fund 29 projects totaling \$100,000.
The Village of Livonia steering committee has completed the development of Façade Renovation Guidelines. Bernie Thoma is now meeting with the Village to begin preparing an application for New York Main Street Funding.
7. FAST TRAC *INTENTIONAL ENTREPRENEUR CLASS* – will be held on Saturday, April 27th in partnership with SUNY Geneseo. As of this writing 8 individuals are registered to participate. The 4 hour workshop is intended for individuals that are considering going into business and is meant to be a lead-in to the 10 week Fast Trac *New Venture* Program.

Another 2,095 voters are considered inactive as they do not have a current address. These active figures will be used to base the number of signatures required for upcoming petitions.
