## PUBLIC DEFENDER – MARCEA TETAMORE <u>Pre-approved Informational Item(s) To Be Reported</u>.

1. PROPOSED USE OF ILSF GRANT MONEY – regarding grant starting June 2014 – Ms. Tetamore explained that she has grant money available again and she would like to create an assistant part time public defender to handle night courts. Night courts are all misdemeanors, so this is a good job for someone fresh out of law school. The grant is \$33,687 per year for three years. She is proposing a start salary of \$25,000 per year. She is not sure if she can find someone for that amount but she would like to start there. She explained the difficulties in the past with part time attorneys' taking family court cases, which then involves conflicts. She would like a restriction put into the job description requirements that they can not take any private cases for family court in Livingston County. This would limit any conflict issues with public defense cases and would allow them to work in any other county. Setting a salary of \$25,000 leaves a balance in her grant money that she would like to use to hire a part time clerk typist for 10 hours per week, which keeps them in the part time status. *Motion: Mr. Gott moved and Mr. Wadsworth seconded to create a part time Assistant Public Defender and a part time Clerk Typist using ILSF Grant money for three years.*

The County Administrator is planning to meet with the County Attorney on the legalities to determine if we can purchase the second ambulance or if a new RFP/Bid would need to be done. Mrs. Dewar reviewed the maintenance issues just to keep used ambulances on the road. There was discussion of the possibility of doing an emergency purchase. Revenues are currently \$20,000 higher than their monthly projections for 2014. Call volumes are up 130 more than last year at this time. There are two ambulances broken down. There are two demos available at Northeastern with less that 1,500 miles on them so all warranties would apply as if they were new.

## Director's Comments:

The contract provides for external marketing initiatives to retain and attract new businesses to Livingston County and will maximize efforts to strengthen the local economy and provide for more and better jobs for community residents.

Mrs. Marshall reviewed the membership history with GRE and explained how they do marketing with site selectors for us generating leads for the county. The amount for 2014 has been reduced by Ms. Marshall. There were other agencies paying less and getting the same service.

Director's Comments:

The public hearing is required to enable submittal of Community Development Block Grant applications under the Regional Economic Development Consolidated Funding Application which was recently announced.

Mrs. Marshall reviewed the announcement that went out recently for applications forwarded to the Board by the Clerk regarding the Community Renewal Block Grant Program. Her office has identified 10 applications that she believes will be submitted for the CFA process.

Motion: Mr. Knapp moved and Mr. Gott seconded to approve the foregoing resolution Carried.

## Pre-approved Informational Item(s) To Be Reported

Livingston County Capital Infrastructure Program recommendations. (A summary of the proposed program guidelines is attached) – Mrs. Marshall reviewed the draft program guide for the committee. Mr. Coyle explained that the County has approximately of \$240,000 in this account to assist in infrastructure. Because of the development interest and because of the activity, we are going to have interest in tapping into the program. Mrs. Marshal explained that the municipality would have to pay for the project up front. We need to make sure that the project actually gets completed. She looks to use AIA documents to seek this reimbursement. Mr. Coyle explained the matching process and that the dollars are not there to allow the program to act as a 50/50 match. There was discussion of where funding dollars could be available to put into this program. Mr. LeFeber stated that he likes the gap; it shows initiative of an applicant. The Committee feels that the draft looks good and Mrs. Marshall will proceed with finalizing the application.

## BUSINESS RETENTION AND EXPANSION PROGRAM

From January 1 to present, department staff has conducted a total of 41 visits, meeting with 30 companies to discuss their business needs. Currently there are 30 active projects; 20 expansion projects (of which 6 are expected to move forward in 2014) 1 retention project, and 9 attraction projects (2 of which are expected to land in 2014). Eight (8) companies received technical assistance for matters regarding international trade. Staff conducted 8 joint company visits with representatives from the US Department of Commerce, the US Small Business Administration, Empire State Development and Workforce Development.

The Economic Development Office hosted and co-presented an introductory workshop for businesses interested in learning how to sell to the federal, state, and county governments. A representative from the Monroe County Finger Lakes Procurement Technical Assistance Center (PTAC) conducted the seminar in conjunction with Economic Development staff who spoke on contracting opportunities with the County. Seven (7) businesses attended the seminar. The workshop received excellent ratings from participants.

The Foreign Trade Zone Advisory Board will be scheduling a press event in the near future to officially announce the recently approved Foreign Trade Zone. The event will be scheduled to coincide with the

anticipated approval of a foreign trade sub-zone at Crossman Corporation. The FTZ is an additional tool for the economic development business retention and expansion program as well as our recruitment efforts.

Greater Rochester Enterprise (GRE) recently announced it is accepting applications for the second round of the Economic Gardening Program. The program, which is the only one of its kind in New York, is designed to provide free, sophisticated, tailor-made technical assistance to second-stage companies that are in expansion mode. In order to participate in the program, companies must be forprofit and privately held, headquartered and operating in the Greater Rochester region, generate between \$700,000 and \$50 million in annual revenue, employ between five and 100 employees, have maintained principal operations in the area for a minimum of two years, demonstrate growth in employment and/or revenue for at least two of the past five years, and provide products and/or services to markets outside of Rochester.

As many as 40 businesses will be chosen to take part in the program. Once accepted, participants have access to a team of national experts provided by the Edward Lowe Foundation, a national non-profit organization dedicated to supporting entrepreneurship, which will help each company develop a plan to further accelerate its business success. Selected companies will also have access to a free suite of high-end, high-speed technical assistance, including help identifying qualified sales leads, mapping to facilitate targeted marketing efforts, reviewing core strategies related to commodity and niche markets, analyzing employee temperament to build strong management teams and recruit talent, examining social media utilization and search engine optimization guidance. This information has been sent to qualifying businesses in Livingston County. In 2013, Once Again Nut Butter and Applied Energy Systems participated in the program.

INDUSTRIAL DEVELOPMENT AGENCY

The Industrial Development Agency has released bid documents for construction of the Tec Drive road extension in the Avon Crossroads Commerce Park. The IDA is expected to award the bid at their May  $2^{nd}$  meeting.

Andrew Reid, Economic Development Representative for the Federal Economic Development Administration visited Livingston County and toured the Crossroads Commerce Park. He discussed the EDA funding application and award process. Representatives from the County, Town, and IDA were in attendance.

## LIVINGSTON COUNTY DEVELOPMENT CORPORATION

The LCDC received 31 applications seeking \$99,000 in funding for the Sign & Façade Improvement Program. Based on the recommendation of the review committee, the LCDC Board awarded 26 projects totaling \$73,900 in funding. For the 3<sup>rd</sup> straight year applications for grants far exceeded the budgeted funding amount. All communities that participate in the Downtown Partnership have seen that funding returned to their community for sign & façade improvements.

## **REGIONAL ECONOMIC DEVELOPMENT COUNCIL**

The state has officially launched the 4<sup>th</sup> year of Consolidated Funding Applications (CFAs). Applications are begin accepted beginning May 1<sup>st</sup> with an application deadline of June 16<sup>th</sup>. The timeframe for project identification and application preparation is significantly decreased from previous years. The Economic Development Office has identified 6 potential projects for application; 2 NY Main Street applications, 2 NY Main Street Technical Assistance applications, 1 small business and 1 strategic planning application. We will be sending information on the funding announcement to county businesses and our economic development partners.

## 3. OPPOSING EXPANSION OF FEDERAL CONTROL UNDER CLEAN WATER ACT

WHEREAS, the U.S. Environmental Protection Agency (EPA) and the Army Corps of Engineers (Corps) have released a 371-page draft regulation for Definition of Waters of the U.S. under the Clean Water Act, and

WHEREAS, both agencies are seeking a rule change to give the federal government more authority by expanding the definition of "navigable waters" in the Clean Water Act, and

WHEREAS, the rule change proposed by the EPA and the Corps would subject almost all physical areas with a connection to downstream navigable waters – including features such as ditches, natural or man-made ponds, and flood plains – to the jurisdiction of the Clean Water Act, and

WHEREAS, the proposed rule change, if adopted, will cause significant harm to local farmers, stall the development of businesses, take control of land used for sustainable food production out of our local providers' hands, and negatively impact County-owned and maintained infrastructure such as roadside ditches and flood-control channels, and

WHEREAS, the costs to our farms, municipalities and taxpayers will be enormous, and

WHEREAS, the New York Farm Bureau, the National Association of Counties (NACo), and the National Association of County Engineers (NACE) oppose the proposed rule change, and

WHEREAS, it is impractical for the federal government to regulate every ditch, pond and rain puddle that may have some tenuous connection – miles away – to a body of water currently defined as "navigable", now, therefore, be it

RESOLVED, that the Livingston County Board of Supervisors hereby strongly opposes the EPA and Corps

expansion of the Clean Water Act, as proposed, and be it further

RESOLVED, that the Clerk of the Livingston County Board of Supervisors is hereby directed to forward a certified copy of this Resolution to the Environmental Protection Agency, the Army Corps of Engineers, U.S. Senators Schumer and Gillibrand, U.S. Congressman Collins, NYS Governor Cuomo, NYS Senators Young and Gallivan, NYS Assemblyman Nojay, the National Association of Counties, the National Association of County Engineers, the New York State Association of Counties, the New York Farm Bureau, the NYS County Highway Superintendents Association, and the Western New York Inter-County Association.

Mr. Higgins explained that several counties have already adopted or are in the process of adopting a resolution opposing federal control expansion under the clean water act. This would have a huge negative impact on the farming and municipality communities. Mr. Yendell reported that this resolution is also on the InterCounty agenda for this Friday. Mr. Schuster explained that the NYSAC Blue Ribbon Task Force on Farming also opposed this.

Motion: Mr. Gott moved and Mr. Knapp seconded to approve the foregoing resolution...... Carried.

## Informational Item(s) Written Only

1. The Shop Manager recently broached the subject of possibly doing our own NYS Vehicle Inspections on our Highway Department fleet (Heavy, medium, light, and trailers.) Historically we do all the repairs, prep work, and pre-inspections...then take the vehicle (usually to Dansville) for the Inspection/Sticker. The Shop Manager has calculated significant savings in cost and time if we do our own inspections. Supt. Higgins reached out in a survey to the Counties statewide. With 32 respondents, 28 Counties do their own Inspections, while only 4 send them out. Currently the Shop Manager and one Automotive Mechanic are Certified for NYS Vehicle Inspections for both heavy & light vehicles. A second Automotive Mechanic is certified for light vehicles, but can easily obtain certification for the heavy classification. County Administrator Coyle and County Attorney Morris have approved this proposal, and the Department has started the process of obtaining the required computer equipment.

There was discussion whether the inspection station is liable if something went wrong and they are not.

There would need to be a computer purchased that is connected to the state for approximately \$1,375-\$2,500 including the additional support equipment recommended by Chairman Gott.
