<u>Director's Comments:</u> This resolution will set the required public hearing on the 303b petitions for inclusion in the Livingston County Agricultural District Program.

Ms. Ellis explained that every September is the month that the Board of Supervisors collects petitions from individual landowners interested in having their property included in the agricultural program. The Ag and Farmland Protection Board will review those petitions in October and the Board of Supervisors would hold a public hearing in November for acceptance of those petitions. To date seven parcels have submitted petitions for inclusion in Ag Districts 1, 3 and 4 totaling 52.4 acres.

CENTRAL SERVICES - DAVID ALLEN

Pre-approved Informational Item(s) To Be Reported

1. Old Jail Roof Project – Options for Repair/Replacement. Reporting with Jim Parlavechio – Clark Patterson Lee

Mr. Allen introduced Jim Parlavechio of Clark Patterson Lee. Mr. Allen reviewed the scope of work for the roof of the jail. This project includes old jail roof and the flat roofs. Mr. Parlayechio reviewed the plan for the needs of the roof. The plan is to go over the metal roof using purlins would fasten down to the rafters. Two layers of insulation would be added within that to go from an R-12 to an R-20 energy code. This attic is heated so it can not rely on what is in there now. Mr. Parlavechio displayed a sample of a structural standard seamed roof panel. These panels are symmetrical and can be removed if any additions are made to the building. While the color will not match the Government Center roof exactly, it will be close. This process will not require moving any of the inmates. Corfu Fire Department and Community Center is using the exact same concept. The panel clips will attach to the z purlins. The pull test was not required because the panels will be hooked directly to metal. There was discussion regarding the life expectancy of the current roof. The roof is becoming a maintenance headache. Mr. Allen explained the variety of problems with this roof over the years. Mr. Coyle explained that the need for a new roof was considered six or seven years ago in the preliminary reconstruction project, but was removed due to cost constraints. The attic has a very high humidity level and is not ventilated properly. The plywood shows staining from moisture, which needs to be addressed before deterioration starts. There was discussion of any utility cost savings that will be realized with a new roof by going from an R12 to an R20 energy rating. There was discussion of the bidding specifications. Mr. Parlavechio explained that a general contractor is not needed. It could be a roofing contractor or it could be an HVAC contractor with a roofing component. There are two HVAC units that service the jail that are 30+ years old. If the flat roofs are included in this project, the HVAC units sit too low and will need to be picked up to be properly flashed in to the roof. The energy efficiency is not there with the old HVAC units. A crane will be used for the roof and will be available to move the HVAC units at this time. A new lightning protection system would be required to bring the whole building into compliance. There was discussion on the condition of the stained plywood and checking for any rot. The shingles on the hip roof will be replaced with metal to match the rest of the building. The flat roofs range anywhere for nine to seventeen years old. If the flat roofs are done now, they would be a built up roof similar to the Millennium building and would have a 25 year leak tight manufacturer warranty. Mr. Parlavechio explained the warranty limitations. There is a two year labor and material warranty from the contractor. There was discussion of the timing of this project. Mr. Parlavechio feels that this is a spring project that would be four months to completion. The drawings are approximately 65% complete. There was discussion of the budget and using some of the smaller roofs as alternates. It is best to do this project under a single source warranty. Mr. Coyle explained that he anticipates using some of the extra boarding revenue toward the cost of this project. We are currently taking in \$70,000-\$75,000 a month in boarding revenues right now. At year end we will have a balance of probably \$700,000-\$800,000 ready to appropriate. Consensus of the

BOARD OF ELECTIONS - NANCY LEVEN AND LAURA SCHOONOVER Pre-approved Informational Item(s) To Be Reported

1. ELECTION UPDATE – Ms. Leven updated the Committee on the controversial primary election and reviewed the color coding of the poll books and the ballots. Ms. Leven also explained that they did do a lot of extensive training with their inspectors this year. They did a PowerPoint presentation and stressed numerous times that this was a two part primary and the color coding to be used. They have no idea how ballots were not distributed correctly. Ms. Leven explained that the cost to produce the ballots with their new copier for \$.14 each versus \$.57 each last year. Ms. Leven explained that there were issues in other areas of the state. There seemed to be more errors this year than in other years. There was discussion regarding more intensive screening of the election workers and not necessarily using election inspectors in their districts. It is a very long day for some people. There was discussion of what to do next time to avoid the same situation from happening again. Ms. Leven reported that they are sending out absentee ballots to the military this week. There was discussion on the possibility of recruiting high school seniors or college students from their government class to participate as inspectors. Ms. Leven explained that this is not done at this time. They do have registration sessions in some of the local schools.

Informational Item(s) Written Only

1. Election supplies were readied and the Primary Election for enrolled Republicans and Conservatives was held on September 10, 2013. Affidavits and remaining absentee ballots were counted on September 17th with a small gallery made up of candidates, candidate representatives, the Conservative Chairman and

- the media watching. The Conservative election resulted in a tie with the Conservative Committee selecting their candidate for the general election ballot.
- 2. On Primary day, 410 phone calls came in to the Board with an average length of 1.5 minutes.
- 3. A change needed to be made to the polling site for the town of Lima the week before Primary Day due to the elevator breakdown in the town hall. The Lima Fire Hall was used and was not ideal; a new location is being secured for November. A change will be made in Nunda since one of the locations no longer wishes to be a polling site. The firemen have approved us to use their new fire hall but we will need to make sure is ADA compliant.
- 4. Caucuses have been completed with 30 being held.
- 5. One independent petition had specific challenges made to it. After much research, the Commissioners ruled it invalid.
- 6. The Certification of Offices notice was mailed to the village clerks to return to us with the positions that will need to be on the March ballot. Caucuses for village offices will be held January 21 through 28, 2014.
- 7. School presentations are once again happening in the schools of Avon and York. For those students who are eligible they will complete registration forms during these sessions
- 8. Preparations are proceeding for the November election. Military absentee ballots are due to be mailed on October 4th.
- 9. The Commissioners participated in a statewide conference call with the State Board on September 26.
- 10. Full document imaging continues.
- 11. Active voter registration enrollment stands at 36,936 voters. Democratic: 9,834; Republican: 16,329; Conservative: 788; Working Families: 146; Independence: 1,795; Green: 113: Blank (no party): 7,591 and 340 others.
- 12. Since the first of the year: 1, 122 new registrations, 161 name changes, 1,236 residence changes, 1,131 mailing addresses, 374 personal information changes, 201 duplicates, 8 incompletes, 437 pending party changes (90 since Primary Day), 815 cancellations, 1,362 inactive changes and various other changes have been processed.

RESOLVED, the Chairman of the Livingston County Board of Supervisors hereby designates the Livingston County Highway Superintendent as the Responsible Local Official (RLO) for EBO-related purposes only, subject to review by the County Administrator and the County Attorney.

- 1. BUSINESS RETENTION & EXPANSION PROGRAM Activities for the month of September include the following:
 - Conducted visits to 10 companies
 - Conducted a total of 11 visits (multiple visits needed for projects)
 - Identified additional 2 new projects. This brings this year's total to 34 projects the department is working on: 24 are expansion projects, 3 are retention projects and 7 are attraction projects (outside companies considering relocating or expanding into Livingston County)
 - Representatives from Economic Development partner agencies including Empire State
 Development, US Department of Commerce and the International Business Council participated in
 some of the company visits.
- 2. INDUSTRIAL DEVELOPMENT AGENCY WNY Enterprise LLC project in the Town of York was induced by the IDA. The \$12 million, 14,000 square foot facility will take raw milk from 8 area farms and separate the milk in to cream and low-fat, high-protein skim milk. This will provide a value-added product for yogurt, cheese and ice cream manufacturers. The new facility will create 11 new jobs. There have been several recent inquiries to purchase property in the Avon Crossroads Commerce Park including 2 site visits during the month of September. The IDA has accepted a purchase offer for a 5 acre

parcel north of Genesee Valley Motors. The Economic Development Director met jointly with the Avon

Town Board and the Avon Town Planning Board to discuss future development of the Park. The boards and the IDA are in agreement to move forward to complete Tec Drive and the needed infrastructure to open up several 10 -15 acre lots for development. The Economic Development Office is now working to secure grant funding to complete these improvements.

- 3. GRANT AWARD FOR RAIL LINE IMPROVEMENTS Governor Cuomo recently announced a \$3.7 million grant award for the rehabilitation of the rail line from Caledonia to Dansville. The section between Mt. Morris and Dansville has been in dire need of improvements to the grade crossings and rail ties for many years. The line is essential for the businesses located in the 4M Complex (former Foster Wheeler facility) who are rail dependent, serving both the energy and transportation industries. The Economic Development Office and Planning Department worked tirelessly for more than a year to secure the funding.
- 4. FOREIGN TRADE ZONE Ontario County Economic Development Corporation is in the process of applying for status as a Foreign Trade Zone Grantee. The application was submitted to the Foreign Trade Zone Board and has been assigned a docket number as part of the application process. Deputy Director, Carolyn Baker-Scott attended the press conference held by Senator Gillibrand to urge the US Commerce Department to approve the application. Approval is anticipated in 2014.
- 5. LIVINGSTON COUNTY DEVELOPMENT CORPORATION The Downtown Partnership was featured in the September 13, 2013 Rochester Business Journal. (*A copy is attached.*) The article highlights the transformation that has taken place in the Villages of Mt. Morris, Dansville, Lima and Geneseo. Development Corporation Downtown Coordinator, Louise Wadsworth as well as several property/business owners were interviewed for the article.
 - Projects funded under the 2011 NY Main Street Grant award in the Village of Geneseo will be completed by November 1. The 2012 NY Main Street awards made in the Villages of Nunda and Avon are now underway. The projects in these villages are the first in New York State which were awarded in 2012 to be completely set up under construction.
 - A SUNY Geneseo intern has completed an update of the Dansville Business Inventory and has started an update of the Mt. Morris Business Inventory. The inventory lists all properties located in the central business district, complete with a copy of the Village's Façade Renovation Guidelines, photo of the property/building, owner information, assessment, and building size. Copies are given to the Village and local Chamber of Commerce.

QUARTERLY UPDATE: CURRENT PROJECTS

Government Center Exhibit:

Five of the seven panels for timeline exhibit for the Government Center are done. This covers the time period from the Iroquois Confederacy through the rise of industrialization (c.1400s-1945). The layout for the final two panels is still in process.

Heritage Trails in Livingston County:

This is a collaborative initiative with Tourism Director, Lisa Burns to create OnCell audio tours of the historic sites throughout Livingston County. The first tour is the Sullivan Campaign Trail audio tour went live in mid-February.

A second audio tour of all the Civil War Monuments and Memorial Halls in the county is in process and anticipated to be live on (or about) Oct. 1st. Rack cards for the first two tours were created and will be widely distributed throughout the county and state this Fall by the Tourism Director and myself. Future development of several more Heritage Trails in Livingston County is anticipated in 2014.

Community Arts Grant Project:

Production of a DVD entitled "Local History Out Loud": 24 readers (town historians, county employees, community leaders) have been scheduled late September – mid October to record brief narratives related to early Livingston County history. I am now working on music selections and visual images.

Book Project:

Geneseo/Groveland Vietnam Veteran's book project – I am assisting these veterans in their efforts to write a book on soldier's experiences. More than 30 veterans from the Geneseo School District have submitted surveys and photographs for this project.

Organization involvement:

- Government Appointed Historian's of Western New York As current Executive Chair of this organization that encompasses 11 counties in WNY, I am overseeing several projects including the coordination of the fall meeting to be held Saturday, October 5th in East Aurora.
