Action Item(s) To Be Reported

1. AUTHORIZING THE IMPLEMENTATION AND SUPPLEMENTAL AGREEMENT #2 WITH NYS DEPARTMENT OF TRANSPORTATION FOR PRELIMINARY ENGINEERING, DESIGN, CONSTRUCTION, CONSTRUCTION INSPECTION AND CONSTRUCTION SUPPORT PHASES AND FUNDING IN THE FIRST INSTANCE 100% OF THE FEDERAL-AID AND STATE “MARCHISELLI” PROGRAM-AID ELIGIBLE COSTS, OF A TRANSPORTATION FEDERAL-AID PROJECT (PIN 475533), AND APPROPRIATING FUNDS THEREFOR: BRIDGE REPLACEMENT PROJECT, WALNUT STREET OVER KESHEQUA CREEK, VILLAGE OF NUNDA

WHEREAS, a project for the replacement of Walnut Street Bridge over Keshequa Creek, Village of Nunda, Livingston County (NYSDOT PIN 475533) (the “Project”) is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs of such program to be borne at the ratio of 80% Federal funds and 20% non-federal funds; and

WHEREAS, the County of Livingston desires to advance the Project by making a commitment of 100% of the Federal and non-Federal share of the costs of the Engineering, Design, Construction, Construction Inspection and Construction Support phases; and

WHEREAS, Livingston County Resolution No. 2013-322 authorized and funded a total of \$754,000.00 for all phases of the project, and

WHEREAS, the bridge replacement project is now complete, and this Resolution captures final project costs and additional Federal and State funding now, therefore be it

RESOLVED, that the Board of Supervisors, duly convened, does hereby approve the above-subject Project, and be it further

RESOLVED, that the Board of Supervisors hereby authorizes the Chairman of the Board to pay in the first instance 100% of the Federal and non-Federal share of the cost of all phases of the project, including: Engineering, Design, Construction, Construction Inspection and Construction Support phases for the Project or portions thereof, and be it further

RESOLVED, the total sum of Eight Hundred and Thirty-Five Thousand Dollars (\$835,000.00) (of which, with anticipated Federal Aid and NYS Marchiselli Aid, the County share will be approximately 13.7% or \$114,727.00) is hereby appropriated from the Board of Supervisors and made available to cover the cost of participation in all phases of the Project, and be it further

RESOLVED, that in the event the full Federal and non-Federal share costs of the Project exceeds the amount appropriated above, the Board of Supervisors shall convene as soon as possible to appropriate said excess amount immediately upon notification by the New York State Department of Transportation thereof, and be it further

RESOLVED, that the Chairman of the Board of Supervisors be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or Marchiselli Aid on behalf of the Board of Supervisors with the New York State Department of Transportation in connection with the advancement or approval of the Project, and providing for the administration of the Project and the Municipality’s first instance funding of project costs and permanent funding of the local share of Federal-aid and State-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible, and be it further

RESOLVED, that a certified copy of this Resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project, and be it further

RESOLVED, that this Resolution shall take effect immediately.

WHEREAS, the County of Livingston desires to advance the Project by making a commitment of 100% of the Federal and non-Federal share of the costs of the Scoping, Preliminary Engineering and ROW Incidental phases; now, therefore be it

RESOLVED, that the Board of Supervisors, duly convened, does hereby approve the above-subject Project, and, be it further

RESOLVED, that in the event the full Federal and non-Federal share costs of the Project exceeds the amount appropriated above, the Board of Supervisors shall convene as soon as possible to appropriate said excess amount immediately

ECONOMIC DEVELOPMENT

Regional Economic Development Council Consolidated Funding Application awards will be announced on December 10th. The Economic Development Office submitted applications for 10 potential projects; 2 NY

Main Street applications, 2 NY Main Street Technical Assistance applications, 1 NY Main Street Anchor application, 1 small business, 2 economic development, and 2 strategic planning applications.

3. AMENDING THE 2014 DEPARTMENT HEAD SALARY SCHEDULE: SHERIFF'S DEPARTMENT

RESOLVED, that the 2014 Department Head Salary Schedule is amended as follows:

Sheriff's Department

Create one full-time Emergency Communications Director position, establish rate of pay and refer to Ways and Means Committee.

The Undersheriff explained that currently Mike Bradley is a Road Patrol Sergeant. Sergeant Bradley has put in his paperwork and is retiring effective January 10, 2015. The Road Patrol Sergeant position does not realistically fit a Road Patrol Sergeant's duties. They would like to correct that, proposing a new position of Director of Emergency Communications. The new position duties statement is being worked on Personnel. They would like to appoint a civilian to run that division. That appointment would then be pending jurisdictional classification with the Personnel Office. Personnel would then send that to the Civil Service Board for them to rule on it determining an exempt or competitive classification. If competitive, a test would need to be held and the appointed person would need to take the test and be reachable on the list. Mr. DiPasquale questioned the change to a civilian position. Sheriff Dougherty explained that Sergeant Bradley falls under the road patrol in a sworn position. Sheriff Dougherty feels that this is not really a road patrol position. It's really its own division of the 911 Center and Communications. It would be similar to the Undersheriff and the two Chiefs as an appointed position because there is a lot of confidentiality. He does not feel that this is a generic road patrol position or that any of the road patrol people could go into this position and know exactly what the position is going to be or be qualified for it. The position statement is done and they are ready to go forward seeking a qualified candidate. The position will not be a uniformed position, but a suit and tie, business professional managing the 911 center. The person would be directly reporting to the Undersheriff and then to Sheriff Dougherty. The old position will be deleted at a later date. There was discussion the current union issues where Sergeant Bradley reports to the COPS whereas the dispatchers report to LCDSA. The pay and place holding will be go to Ways and Means with the a salary, without the overtime that the position is currently entitled to. Sergeant Bradley has agreed to stay on in a part time capacity to help train a new person. There are 8-9 internal applications and it has been advertised through NYSAC and the local papers.

Mr. Deming questioned if Mrs. VanHorne has received any foil requests regarding town infrastructure. The authority has not received any direct requests, but she has heard from some of their members. She has for some of the towns, stating that they needed at least two months to get all of the paperwork together and asking whether they wanted a copy or a professionally scanned copy for half the price. She is working on getting all of the mapping scanned. She contacted their attorney and there is really no security issue. Mrs. VanHorne believes that these requests resulted from a fairly large explosion in Horseheads and she feels that they are doing a risk assessment to avoid a further calamity. It is fairly common for gas and water mains getting nicked when work is being done.

COUNTY PROJECTS:

LIVINGSTON COUNTY EMERGENCY COMMUNICATIONS PLAN:

NYS Public Safety Answering Point (PSAP) Operations Grant – 2015. On October 16, 2014, Governor Cuomo announced that \$10 Million will be awarded to the NYS PSAP 2015 program. Livingston County will be receiving **\$169,874**. This funding will be dedicated to sustaining operations at the 911 Center.

NYS Public Safety Answering Point (PSAP) Sustainment Grant - 2014. We've been awarded an additional grant of \$89,253 for computer and equipment replacement in the Sheriff's Office, Secondary 911 Center at the EOC, and the plotter in the Planning Office. This grant is 100% state funds. No county match required. This funding will replace old and antiquated equipment.

DANSVILLE TRANSPORTATION AND INDUSTRIAL AND COMMERCIAL ACCESS STUDY:

The consultant continues work on the draft report. The Steering Committee met on November 20, 2014, to review the draft recommendations and implementation strategy.

COUNTY PLANNING BOARD:

Vacancies. **There are 4 vacancies on the Planning Board – 3 for Alternate At-large members; 1 for North Dansville; 1 for Sparta.**

AGRICULTURAL & FARMLAND PROTECTION BOARD (AFPB):

FY2008-2009 Farmland Protection Implementation Grant (Triple H and Sunny Knoll farms). The Genesee Valley Conservancy continued work on these projects. We were informed that both projects received the necessary extensions from the federal government. The request to the State to extend both contracts are in process at the State level.

Agricultural District Renewal. Planning staff continued work for the renewal of Agricultural District #3. The public hearing was held on November 19, 2014. 1. The General Election was held November 4, 2014.
 - Machine delivery was completed on November 3rd to the poll sites; this also included all necessary supplies.
 - "Speed bags" were once again picked up by the town clerks to distribute to the Inspectors.
 - 26 poll sites were open from 6 AM to 9 PM.
 - Paper jams did occur sporadically around the county, this may be due to the ballot being two sided ballot. One machine was replaced in a poll site. New marking pens were used to eliminate bleed through.
 - 918 absentee ballots were requested.
 - 230 voters visited the BOE office to request a ballot. Extra office hours were provided for this purpose during the last two weeks before the election.
 - 93 ballots were taken to the CNR to be voted as required by Election Law.
 - The Sheriff's Deputies returned the "speed bags" and ballot catchers to the BOE on election night except for the town of Geneseo which were returned by the Inspectors. The first bags arrived at 9:45 PM and all bags were returned by 10:25 PM.
 - Complete results were available on the BOE website just before 10:45 PM. Results were then sent to the NYS BOE for their website.
 - The voting machines have been returned to the service center and had their post election work completed along with the required quarterly testing. Two scanners are being sent out for minor repairs.
 - MOVE Act surveys were completed as requested on November 25th.
 - The election is to be certified 25 days after the election which is November 29th.
 - Statistics will be configured once certification occurs. Over 51% of the voters of the county voted.
2. Party affiliation changes were requested by over 300 voters and are in the process of being changed.
3. The backlog of registration work has started again now that the election has been completed.
4. Registration lists have been requested by a few fire districts for their elections.
5. Scheduling of meetings continue for the re-districting consolidation committees. Meetings are being scheduled for Avon, Caledonia, Conesus, Groveland, Leicester, Lima, North Dansville and York.
6. Commissioner Leven participated in conference call with the NYSBOE on November 19th and Commissioners Schoonover and Leven participated in a statewide call on November 20th. The next calls will be on December 17th and 18th.

1. 25 County personnel completed FEMA Situational Awareness/Common Operating Picture. The training focused on obtaining situational awareness from the scene of the incident/event and the reporting structure for the information. The training concluded with an exercise in the process and obtaining the appropriate resources based on the information reported to the Emergency Operations Center.
2. FEMA/State representatives for the May disaster have concluded their work in the County on Tuesday November 25, 2014. The project worksheets written for the County, Towns and Villages total over 1.9 million dollars. The Governor announced on Monday November 24, the State will cover the additional 25% cost share. There will be no match for the County, Towns and Villages. The State has not released the 404 Mitigation funding for the disaster as of yet, several Towns did qualify for large scale projects that will qualify under the 406 Mitigation funding supplied by the State.
3. One of the largest fires in the County occurred at the Commodity Resource Corporation in Caledonia, 7 fire departments from the county along with 20 additional fire departments from Monroe, Genesee, and Wyoming Counties assisted Caledonia in the extinguishment. The investigation concluded four days later with the preliminary investigation determination to be spontaneous combustion. The following Wednesday a fire burned down a barn at the Worm Power business located on Jenks road in the Town of Avon, preliminary determination of the cause is an extension cord plugged into a block heater for a tractor. 2 days later there was a house fire in Sparta, the cause of the fire was a failure in the chimney that was used for the wood stove. 2 days after there were 2 house fires in the Town of Avon. It was extremely busy week for the Fire/EMS departments in the County and I would like to commend their efforts, and hard work during this time.
