PERSONNEL ISSUES

- 1. SHERIFF'S DEPARTMENT REFERRED FROM THE PUBLIC SERVICES COMMITTEE(SHERIFF DOUGHERTY AND UNDERSHERIFF BEAN
 - AMENDING THE HOURLY EMPLOYEE SALARY SCHEDULE: SHERIFF'S DEPARTMENT

RESOLVED, that the 2014 Hourly Employee Salary Schedule is amended as follows:

Sheriff's Department

Create one full-time Deputy Sheriff/Sergeant (Identification Division) position grade 15.

Comments: The Sheriff would like to make a provisional appointment pending the exam. It is important to have a person familiar and experienced with these duties.

Sheriff Dougherty explained that this allows for a person with more experience to supervise the identification technicians.

• AMENDING THE DEPARTMENT HEAD SALARY SCHEDULE AMENDING THE DEPARTMENT HEAD SALARY SCHEDULE AND ESTABLISHING THE SALARY FOR THE POLICE SERVICES COMMANDER: SHERIFF'S DEPARTMENT

RESOLVED, that the 2014 Department Head Salary Schedule is amended as follows:

Sheriff's Department

Create one full-time Police Services Commander position, and establish an annual salary of \$77,000 for Matthew Burgess, appointee to the position.

Comments: In realigning the departmental command structure, this position would oversee the Patrol Services, including the Investigations division and Road Patrol division.

Undersheriff Bean reviewed the old organizational structure versus a new organizational structure allowing for a Chief Deputy of Police Services, Police Services Commander to oversee the Investigations and Road Patrol divisions. Sheriff Dougherty explained that they have already been operating under the new structure, improving the moral between the two divisions by having two working Captains reporting to the Commander. This allows for a more efficient working environment, allowing for a cost savings by going from three administrative positions to two. January has had a large caseload and Investigations are very busy. The sixth investigator position was approved to fill in 2013, but was not filled. Right now, the Sheriff does not see expanding to the sixth investigator position. Closure rates were way down in 2013. Sheriff Dougherty is very confident in Brian Applin's abilities. The Commander will cover their duties in the absence of the Captains. In the past, these two divisions did not mesh well. Jail Deputies are now getting involved in cases and have recently solved two cases.
