# PLEDGE OF ALLEGIANCE

The Chairman Gott introduced Michael Kemp:

Michael Kemp was born in Rochester, NY and is a 1994 graduate of Livonia Central School. Michael enlisted in the United States Marine Corps in 1996 and served in the infantry w/3<sup>rd</sup> Battalion 4<sup>th</sup> Marines and as an embassy guard at the American Embassy Prague, Czech Republic and the American Embassy Hanoi, Vietnam. Michael participated in numerous operations during his time in the Marine Corps to include Operations Hunter Warrior "Sea Dragon", Forest Light, Czech Republic's accession into NATO, Bi-lateral trade agreements between the United States and Vietnam, presidential dignitary protection details for President Clinton at the G-8 Summit in Okinawa, Japan, the Bi-lateral trade agreement signing in Hanoi, Vietnam, and a Secretary of State dignitary protection detail for Secretary Albright in Moscow, Russia.

Michael separated from military service in 2001 to pursue his educational and professional goals. Michael has a Bachelor of Science Degree in Political Science, an Associate Degree in Criminal Justice and an Associate Degree in General Studies. Michael is currently pursuing a graduate degree on a part-time basis. In 2002 Michael interned with New York State Office of Public Security Intelligence Division, and also interned with the U.S. Department of State Bureau of Political-Military Affairs. In 2003 Michael accepted fulltime employment in the field of Counterintelligence with the U.S. Army Intelligence and Security Command and eventually transitioned operationally working as a security contractor in Iraq and Kuwait running intelligence and security missions. Upon returning home from overseas in 2007, Michael began employment with Livingston County Sheriff's Office where he currently works as a Deputy Sheriff Corrections Officer.

In 2011 Michael re-entered military service enlisting in the New York Air National Guard 107<sup>th</sup> Air Wing at Niagara Falls Air Reserve Station. He initially served with the 107<sup>th</sup> Security Forces Squadron and in 2013 transferred to the 107<sup>th</sup> Force Support Squadron where he continues to serve today as a Unit Career Advisor and the Team Leader in the Tactical Operations Center (TOC) for the 107<sup>th</sup> Air Wings Fatality Search and Recovery Team's Homeland Response Force Mission. Michael's major federal awards and decorations include a Meritorious Unit Commendation, Good Conduct Medal, National Defense Service Medal, Global War on Terrorism Service Medal, Sea Service Deployment Ribbon, Overseas Service Ribbon w/ 1x star, and the Marine Security Guard (Embassy Duty) Ribbon. His state awards and decorations include Operation Enduring Freedom Service Ribbon, Operation Iraqi Freedom Service Ribbon, and the Humane Service to New York State Medal.

#### Bill Bacon Comments:

Good afternoon. The purpose of today's public hearing is to provide information to the public regarding the Community Development Block Grant Microenterprise Program and to consider comment regarding the proposed application being requested for submittal by Livingston County. An application in the amount of \$104,000 is being proposed to the New York State Office of Community Renewal to provide grants in conjunction with capacity building and entrepreneurial assistance to support and foster the development of four microbusinesses to be located in Livingston County with the anticipated job creation of twenty in total. Pending a successful outcome of the grant application, it is proposed that the County would then enter into a sub-recipient agreement with Livingston County Development Corporation to administer the program through a business plan competition available to any participants interested in owning and operating a craft beer brewing business, again located within the County. The initiative is intended to fill a business gap and create further opportunity in the burgeoning food and beverage industry. In addition to the grant awards, technical assistance will be offered as part of the business plan preparation where access to the accounting, legal and marketing professionals with an expertise in this arena can provide professional support. These plans will be scored and ranked using a rubric designed for objectivity and consistency is determining the awardees.
