Doug Best's term was up this year. Councilperson Gardner, as Liaison to the PB, ZB and Ag board, stated that advisory boards meet a limited number of times due to application activity, that volunteer members gain valuable experience as they participate in application review and attend required annual training and that she stands by her recommendation that experienced members with records of good conduct, attendance and participation be reappointed when they request to serve another term. With that, she recommended reappointment of Doug Best to the planning board. Councilperson Mayer and Carey agreed.

Councilperson Marcellus asked if this discussion was based on reappointment or policy changing. Falk stated there are not enough young people from the community on boards. Gardner said she believes that age is not a relevant factor, but pointed out that there are 2 new members to the board, Village appointees, Ericka Gruschow & Andrew Britton. Marcellus suggested we work on process first and then appointments/reappointments.

During above discussion Doug Best asked to speak to the board and mentioned his involvement with the community of Lima for a long time serving on many boards. He mentioned the planning board is his major commitment and understands that Supervisor Falk wants change and change is good but that he sees a handful of people wanting to volunteer and having not been educated to these roles. He suggested a new alternate be mentored by the current board for future.

Supervisor Falk, after the above discussion, agreed to reappointment Mr. Best.

Discussion was held regarding the opening for an alternate member to the planning board. Agreement was reached to advertise the vacancy to solicit applications from any interested member of the community. Once all applications are compiled, board members will review applicant qualifications and establish an interview process.

\*\*Supervisor Falk said this board has no structure or minutes and applicants have showed interest for this board. Councilperson Marcellus did take minutes at the last meeting and agreed minutes should be taken so the community is aware of what's happening and structure be put in place for this commission. Councilperson Gardner stated the town board has never appointed members for this board in the 10 years she has been Councilperson. John Correll of the village board said there have never been any officers, President or Vice President, on this board. Marcellus suggested placing this topic on the agenda for discussion at the joint town and village board February 13<sup>th</sup> at 6:30 PM. Councilperson Gardner mentioned that the Town and Village enacted a joint regulation for the park in 2015, and that it dealt with park policies and management, but that she did not recall reference the park committee as part of that agreement. Falk mentioned he heard the village crew does most of the work because they are cheaper. Councilperson Gardner said that was inaccurate, that she had never heard of park work being allocated on the basis of wages. Rather, the town highway crew rates reflect the equipment they operate and they are engaged in town and county roadwork during the summer months, while the village crew is staffed to maintain the park, with half of these costs paid by the town

# **Resolution #1 of 2018 – Blanket Undertaking**

RESOLVED, that the Lima Town Board consents and approves a blanket undertaking to cover all officers, clerks and employees required by law to post an undertaking which undertaking shall be provided by the following policies:

- Public Officials Liability Policy, provided by NYMIR, Policy Number MPOLTMA001.
- Government Crime Policy provided by NGM Insurance Company, Policy Number F200038.

# **Post Office**

Supervisor Falk spoke with Tonya, USPS, who said the Post Office ceiling is leaking and water can be heard dripping behind the wall. Supervisor Falk is meeting with Tanya to walk through other potential locations for the post office. Their lease is up October 2019. Updates will follow as information becomes available.

# **Speed Trailer**

Supervisor Falk said he has a packet of information on different types/styles of radar equipment. He will give this information to Highway Superintendent Arner to determine the proper set-up in order for the equipment to gather speed information. Councilperson Gardner indicated that study of speed monitor purchase had been started at her suggestion and she volunteered to work with Arner on evaluation of equipment and Falk agreed.

# Extend Temporary Land Use Moratorium Prohibiting Large Scale Solar Installations

Councilperson Gardner informed the board that she contacted Jessica Bacher, seeking an update on the State's upcoming guidance document for siting in

agricultural communities and that she will advise the board when it is finalized. After board discussion it was agreed to have Town Attorney James Campbell draft a local law extending the current moratorium in place, prohibiting large scale solar installations. This local law will be reviewed and discussed at the February 6<sup>th</sup> meeting. If agreed, a public hearing to pass said proposed local law will be held at the March 6th meeting.

# **Blue Heron Logistics**

Supervisor Falk informed the board that Blue Heron Logistics, LLC will be the Lima Crossroads Blues Festival Sponsor of \$2500. Kudos goes to Jim Shelley for soliciting said donation.
