General Code Update

Moratorium Prohibiting Large Scale Solar Installations in the Town of Lima

Town Attorney Kruk distributed a draft local law titled "A local law establishing a temporary land use moratorium prohibiting large scale solar installations within the Town of Lima". This local law is intended to temporarily prohibit the creation or siting of large scale solar power installations within the Town of Lima for a period of up to twelve (12) months, pending the development and adoption of local laws and/or ordinances prepared to regulate and govern such installations. This temporary moratorium follows the resolution of the Town Board at its regular meeting on April 7, 2016 to enact a temporary moratorium.

After discussion Councilperson Gardner made a motion to send same the Livingston County Planning Board and hold a public hearing at the July 7th board meeting, seconded by Councilperson Mayer the vote went as follows: CARRIED Ayes: 5 Yendell, Gardner, Mayer, Carey, Marcellus
