GEORGE GOTCSIK: George informed the Board that Rose Reynolds has resigned from the Planning Board after serving two (2) terms. Two (2) positions are now available for village residents on the Planning Board.

Building Inspector reports for December 2016 and yearly totals for 2016 were given to the Board. Ambulance, Financial, WWTP reports and Jobs Completed by Village Crew were given to the Board.

Trustee Correll mentioned that NYS is sponsoring an Urban Forestry Grant for a minimum of \$10,000.00 with a 25% match.

Teen Recognition nomination forms are available at the Village Office. Deadline is Feb. 10, 2017.

Discussion was held on the Deer Population issue. Trustee Warsaw has a friend, Eric Scott, who is willing to volunteer to look into the situation regarding the deer population problem, controlled hunts etc.

Board suggested having Mr. Scott contact the DEC and report back to Trustee Warsaw. Clerk will poll other Livingston County villages on any deer population measures.

Mayor Luft informed the Board that the tax cap for the 2017-18 budget year will be 1.15%. He feels it is now time to override the tax cap this year.

Letter was received from Building Inspector detailing conditions to be met before the Village will accept dedication of Hogan Avenue. This was reviewed by the Board.

The Board Budget meeting will be held on Mar. 22nd at 7:00 pm.

Attorney Kruk presented the water agreement between the Town and Village. The split for 2016 is 10% from the Town and 90% from the village for water utilities etc.

Motion made by Jerry Warsaw, seconded by John Correll to enter into the Water Agreement with the Town of Lima, with the Town paying 10% and the Village paying 90% of the water costs. Motion unanimously approved.

Ben informed the Board that a local painter has expressed interest in painting the Historic signs in the village. Discussion was held.
