MOTION

Fire Department Report was given to the Board. Jim stated that the tips and cutters on the Jaws of Life were damaged at a fatal accident in West Bloomfield and the injured persons insurance will not pay to repair it. Our insurance, Stan Steele Agency also tried to collect but was not successful. Jim has received three estimates to buy new tips & cutters with a 60,000 lb. cutting strength.
