Fire Department Report was given to the Board. Fire chief reported that \$3500.00 was made from the Boot Drive for the West Webster Fire Dept. Rusty also inquired as to whether the Fire Dept. could hold drills inside the Duffy house. Mayor Luft replied that the eviction process has not been resolved but his request will be kept in mind. Fire chief asked for approval to send several members of the Fire Police to a seminar in Monroe County at a cost of \$20.00/person.

WWTP report was given to the Board. DEC did their annual inspection of the WWTP. They found all to be in compliance with State regulations.

Trustee Warsaw discussed band locations for Crossroads Day. Three (3) bands will be playing throughout the day. Black Ice will start playing at 12:30, Patrice Trio will perform from 5 pm until 8 pm and Bat McGrath will start at 8:30 pm. Tickets for the McGrath concert will be \$20.00/person. A tent will be erected for the bands to play under. Due to financial constraints Crossroads Council will not purchase an ad in the Tourism Guide this year.

Mayor Luft brought up the idea for a drop box to be installed at the front door. Clerk will check on this with the Town.

The Main Street Grant Program is now completed. A final inspection was made and all reimbursement checks have come in.

A Downtown Partnership Revitalizing Communities brochure was distributed by Livingston County Development. A copy will be sent to Julia Bean, as her shop is included in it.
