JULIA BEAN: Ms. Bean had comments regarding the Crossroad Day Festival. She stated that smoke from "Charlie's Chicken" came into her business, and it was located in front of Ruck's Pizza. Parking was haphazard and it was very disorganized. Discussion was held on this matter. Trustee Warsaw, liaison to the Crossroads Council, stated that these concerns were brought up at a Crossroad Council meeting held the previous evening. In the future venders will not be placed so close together and "Charlie's Chicken" will be located in another area. Communication with the local businesses needs to take place prior to Crossroad Days and advertising needs to be done in a timely manner. Ms. Bean was thanked for her comments and Mayor Luft stated that this would not be a recurring problem.

Attorney Kruk will give proposed Local Law #2 to the Historical Preservation Committee for review.
