A RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF CALEDONIA REGARDING ADOPTING FINDINGS PURSUANT TO THE STATE ENVIRONMENTAL QUALITY REVIEW ACT IN RELATION TO A PROJECT AND PROPOSED LOCAL LAW INVOLVING AMENDING SECTION 215-4 OF THE CODE OF THE VILLAGE OF CALEDONIA, NEW YORK FOR THE PURPOSE OF REZONING LANDS KNOWN AS MACKAY PARK (PARCEL MAP NUMBER 7.7-1-64) FROM LIGHT INDUSTRIAL (I-1) TO LAND CONSERVATION (LC)

WHEREAS, a resolution was duly adopted by the Board of Trustees of the Village of Caledonia (the "Village Trustees") for a public hearing to be held on May 7, 2013 at the Village Office of Caledonia to hear all interested parties on a Proposed Local Law amending Section 215-4 of the Code of the Village of Caledonia for the purpose of rezoning lands known as MacKay Park (parcel map number 7.7-1-64) from Light Industrial (I-1) to Land Conservation (LC) (the "Project"); and

**WHEREAS,** notice of the public hearing was duly advertised in the official newspaper of the Village of Caledonia; and

**WHEREAS**, the public hearing was duly held on May 7, 2013 at 6:30 p.m. at the Village Office of Caledonia, New York and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said Proposed Local Law, or any part thereof; and

WHEREAS, in accordance with Article 8 of the New York State Environmental Conservation Law and Regulations adopted pursuant thereto by the Department of Environmental Conservation of the State of New York (collectively, "SEQRA"), the Village Trustees completed a Short Form Environmental Assessment Form (the "EAF") with respect to the Project, a copy of which is attached hereto as Exhibit A; and

**WHEREAS**, the Village Trustees, as Lead Agency, has carefully considered the potential environmental impacts of the proposed action against the criteria set forth in 6 NYCRR 617.7(c) and has taken a hard look at the potential environmental impacts as required by SEQRA; now, therefore, be it

**RESOLVED,** that the Project involves an "Unlisted Action" as said term is defined under SEQRA. The review is uncoordinated. Based upon the review of the EAF and related documents completed and reviewed by the Village Trustees in connection with the Project, the Village Trustees, as Lead Agency, hereby finds that (i) the Project will result in no major impacts and, therefore, is one which may not cause significant damage to the environment; (ii) the Project will not have a "significant effect on the environment" as such quoted terms are defined in SEQRA; and (iii) no "environmental impact statement," as such quoted term is defined in SEQRA, need be prepared for this action. This determination constitutes a "negative declaration" for purposes of SEQRA. The findings of the Village Trustees are incorporated in Part II of the EAF.
